ORDINANCE 08-18

AN ORDINANCE ANNEXING 2.36 ACRES OF REAL PROPERTY INTO THE CORPORATE BOUNDARIES OF NIBLEY CITY

WHEREAS, Steven Stowers has petitioned Nibley City requesting annexation of property located at approximately 4333 Hollow Road described herein, and

WHEREAS, the petitioner has accompanied the request with an accurate plat map of the area to be annexed furnished by a duly licensed engineer of surveyor, and

WHEREAS, The City Council feels it is in the best interest of the City to annex said property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF NIBLEY CITY, UTAH, THAT:

- 1. The property described herein be annexed into the City of Nibley. The attachment containing the description of the property is included here by reference and is an integral part of this ordinance.
- 2. The property is hereby annexed into Nibley City.
- 3. The property shall be zoned as Residential Estates (R-E)
- 4. The City Recorder is hereby directed to present the signed plat to the County Recorder and to the office of the Lieutenant Governor of the State of Utah for proper disposition.

BOUNDARY DESCRIPTION

A tract of land to be included in the corporate limits of Nibley, Utah located in the Northwest Quarter of Section 34, Township 11 North, Range 1 East of the Salt Lake Baseline and Meridian described as follows:

Commencing at the Northwest Corner of Section 34, Township 11 North, Range 1 East of the Salt Lake Baseline and Meridian monumented with a Railroad Spike; thence S 00°15'16" E 614.91 feet; thence N 89°11'58" E 1762.99 feet; thence S14°29'52"E 30.00 feet; thence S01°21'52"E 30.57 feet to the POINT OF BEGINNING said point being on the existing Nibley City Corporate Limit Line and running thence along said Corporate Limit Line the next two courses: 1) thence S47'30'00"E 355.44 feet; thence S04'37'00"W 413.67 feet to the east—west center line of the Northwest Quarter of said Section 34 as defined by an existing fence line; thence along said east-west center line of the Northwest Quarter of said Section 34 S89'54'22"W 161.12 feet to the original east bank of the Little Hyrum Canal as now defined by the brow of a hill; thence along said brow the next six courses: 1) thence N23'38'19"W 106.72 feet; 2) thence N00'55'44"E 37.50 feet; 3) thence N18'04'53"E 187.42 feet; 4) thence N00'38'05"E 96.12 feet; 5) thence N29'35'49"W 166.74 feet; 6) thence N01'21'52"W 98.23 feet to the point of beginning, containing 2.36 acres, more or 1633.
