On October 7, 2008, the Centerville City Council passed and adopted Ordinance No. 2008-25, annexing approximately 14.98 acres of property as described below, into Centerville City, pursuant to an annexation petition filed with the City by Integrated Financial Associates, Inc. and Centerville Partners, LLC.

Legal Description of Annexation Property

Being a portion of the Northeast Quarter of Section 36, Township 3 North, Range 1 West, Salt Lake Base and Meridian, Davis County, Utah and being described as follows:

Commencing from the North Quarter Corner of said Section 36: thence N 89°27'02" W, along the north line of Section 36, 112.09 feet to the easterly line of the D&RGW Railroad right of way; thence S 10°42'52" E. along said easterly line, 2292.14 feet to the northwest corner of Parcel 5: coincident with the north line of the Integrated Financial Associates, Inc. property; thence along the north line of the Integrated Financial Associates, Inc. property, N 70°46'00" E, 125.37 feet to the point of beginning; said point also being on the north line of the Centerville City limits: thence continuing along the north line of the Integrated Financial Associates, Inc. property N 70°46'00" E, 321.46 feet to the west line of 650 West Street; thence N 70°32'26" E 101.08 feet to the east line of 650 West Street; thence along the north line of the Centerville Partners LLC property the following (3) courses: N 70°46'00" E 1081.60 feet, and N 18°44'57" E 446.18 feet, and N 89°24'06" E 221.36 feet to the westerly line of the Legacy Highway project; thence S 00°13'25" W 917.31 feet along said westerly line to the north line of existing Centerville City limits; thence S 89°53'29" W 1781.24 feet along said north line to the point of beginning. Contains 14.98 acres.

ORDINANCE NO. 2008-25

AN ORDINANCE ANNEXING APPROXIMATELY 14.98 ACRES OF PROPERTY INTO CENTERVILLE CITY PURSUANT TO AN ANNEXATION PETITION FILED WITH THE CITY BY INTEGRATED FINANCIAL ASSOCIATES, INC. AND CENTERVILLE PARTNERS, LLC

WHEREAS, the City Recorder received an Annexation Petition dated August 18, 2008, submitted by Integrated Financial Associates, Inc. and Centerville Partners, LLC, requesting the annexation of approximately 14.98 acres of unincorporated property in Davis County, Utah, into Centerville City, Utah; and

WHEREAS, the City Council accepted the Annexation Petition for further consideration on August 19, 2008; and

WHEREAS, the area of property proposed for annexation into Centerville City is unincorporated, contiguous, and contiguous to Centerville City, and the annexation of the property into Centerville City will not leave or create an unincorporated island or peninsula; and

WHEREAS, the area of property proposed for annexation into Centerville City is located within the City's Expansion Area, as more particularly described in the Centerville City Annexation Policy Plan as set forth in Part 12-500 of the Centerville General Plan, and the proposed annexation complies with the standards and criteria set forth in Section 12-500-4 of the Annexation Policy Plan regarding future annexations; and

WHEREAS, the Annexation Petition contains the signatures of the owners of private real property, or their authorized representatives, that is located within the area proposed for annexation, covers a majority of the private land area within the area proposed for annexation, and is equal in value to at least 1/3 of the value of all private real property within the area proposed for annexation; and

WHEREAS, the Annexation Petition is accompanied by an accurate and recordable map, prepared by a licensed surveyor, describing the area proposed for annexation; and

WHEREAS, the Annexation Petition was certified by the City Recorder on August 26, 2008, as meeting the applicable provisions of *Utah Code Ann.* § 10-2-403(2), (3) and (4), and a copy of the Notice of Certification was provided to the required persons or entities in accordance with *Utah Code Ann.* § 10-2-405; and

WHEREAS, the City has provided the required notice of the proposed annexation by publishing notice of the annexation once a week for three consecutive weeks in the Davis County Clipper and mailing notice of the proposed annexation to each affected entity as required by law; and

Section 5. <u>Severability</u>. If any section, part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts and provisions of this Ordinance shall be severable.

Section 6. <u>Effective Date</u>. This Ordinance shall become effective immediately upon publication or posting, or thirty (30) days after passage, which occurs first. In accordance with *Utah Code Ann*. § 10-2-425, the annexation of the property shall take effect on the date of the lieutenant governor's issuance of a certificate of annexation.
