In December 2003, the Boards of Education of Jordan School District and Murray City School District approved a boundary change that transferred Braemar Village subdivision from Jordan to Murray School District as that area is part of Murray City. Although the resolution between the school boards was submitted to the county recorder's office, the change was not formally completed. According to the law, your office must be notified of this change.

RESOLUTION

WHEREAS, Braemar Village PUD, a planned unit development in Murray City, State of Utah (referred to in this Resolution as the Braemar Village Area) has been within Jordan School District because the boundary between the districts was defined as running along North Jordan Canal, and the said Braemar Village PUD has been annexed into Murray City;

WHEREAS, the annexation of the Braemar Village Area results in the citizens of Murray City being served by more than one school district, and the presidents of the Boards of Education of Jordan School District and of Murray School District have recommended the adjustment of the boundaries of their Districts to transfer the Braemar Village Area to Murray School District;

WHEREAS, Utah Code Ann. § 53A-2-104 and -105 provide a procedure for the transfer of a portion of a school district and for the disposition of the bonded indebtedness of the transferor school district in the event of such a transfer;

WHEREAS, the transfer of the Braemar Village Area from Jordan School District to
Murray School District does not require the transfer of any school district property (that is, land
owned by Jordan School District) because there is no school district property owned by Jordan
School District within the Braemar Village Area;

WHEREAS, Utah Code Ann. § 53A-2-105 provides for disposition of the bonded indebtedness of the transferor school district allocable to the portion of the school district affected by the transfer;

NOW, THEREFORE, it is resolved by the Board of Education of Jordan School District and by the Board of Education of Murray School District that the Braemar Village Area is hereby transferred from Jordan School District to Murray School District, and the superintendents and

Board Presidents of Jordan School District and Murray School Districts are hereby requested and authorized to present this resolution to the Board of County Commissioners and the State Board of Education and to establish by agreement the disposition of the bonded indebtedness of the Braemar Village Area incurred for the benefit of Jordan School District, in the manner provided by law.
