

AMENDED ARTICLES OF INCORPORATION OF THE CITY OF RICHFIELD

Pursuant to the provisions of the "Utah Municipal Code," the City of Richfield in Sevier County, Utah acting by its Mayor and approved by the City Council, hereby amends its original Articles of Incorporation, dated the 22nd day of February, 1878, and states the following as its Amended Articles of Incorporation:

- 1. The name of the municipality is the City of Richfield; also know as Richfield City Corporation.
- 2. The geographical description of the properties being annexed to the City of Richfield is as follows:

Description

BEGINNING AT THE SOUTHWEST CORNER OF SECTION 19, T.23 S., R.2 W., S.L.B. & M., SAID POINT BEING LOCATED ON THE EXISTING RICHFIELD CITY CORPORATE BOUNDARY; RUNNING THENCE N00°15'35"W 2695.69 FEET ALONG THE WEST LINE OF SAID SECTION 19 TO THE NORTHWEST CORNER OF TAX PARCEL 4-205-5; THENCE N89°32'33"E 1009.98 FEET ALONG THE NORTH LINE OF SAID PARCEL TO THE NORTHWEST CORNER OF TAX PARCEL 4-205-34; THENCE S00°27'27"E 79.20 FEET ALONG THE WEST LINE OF SAID PARCEL TO THE SOUTHWEST CORNER OF THE SAME; THENCE N89°31'49"E 43,34 FEET ALONG THE SOUTH LINE OF SAID PARCEL TO THE EXTENSION OF THE EAST RIGHT-OF-WAY LINE OF A COUNTY ROAD; THENCE ALONG THE RIGHT-OF-WAY LINE (AND EXTENSION THEREOF) OF SAID COUNTY ROAD THE FOLLOWING SIX (6) COURSES AND DISTANCES: (1) S00°37'33"W 806.14 FEET, (2) S88°54'25"W 465.00 FEET, (3) S00°15'35"E 515.01 FEET, (4) N89°32'25"E 12.60 FEET, (5) S00°27'35"E 37.81 FEET, AND (6) \$88°19'39"W 47.19 FEET TO A POINT ON THE WEST LINE OF TAX PARCEL 4-205-32; THENCE S00°27'35"E 265.97 FEET ALONG SAID WEST LINE TO THE SOUTHWEST CORNER OF SAID PARCEL; THENCE N89°32'25"E 298.38 FEET ALONG THE SOUTH LINE OF SAID PARCEL TO A POINT ON THE WEST LINE OF TAX PARCEL 4-205-3; THENCE S00°27'35"E 785.55 FEET ALONG SAID WEST LINE AND THE WEST LINE OF TAX PARCEL 4-205-2 TO A POINT ON THE NORTH LINE OF TAX PARCEL 4-205-35: THENDE S89°32'25"W 326.07 FEET ALONG SAID NORTH LINE TO THE NORTHWEST CORNER OF SAID PARCEL; THENCE S01°28'21"E 200.01 FEET ALONG THE WEST LINE OF SAID PARCEL TO THE SOUTH LINE OF SAID SECTION 19; THENCE \$89°32'25"W 521.95 FEET ALONG SAID SECTION LINE TO THE POINT OF BEGINNING. CONTAINING 49.5 ACRES, MORE OR LESS.

3. The City of Richfield is a "City of the Fifth Class" as defined by § 10-2-301, Utah Code Annotated, having a population of more than 1,000 inhabitants, but less than 10,000 inhabitants.

MINIMUM IN NNEXING SPECIFIC

WHEREAS, a majority of the owners of certain real property described below, desire to annex such real property to Richfield, Utah, said owners, Joseph D. Levine, Darren & Lana Barney, and Fred & Jeneal Wingelaar; and

WHEREAS, said real property consists of approximately 49.5 acres and lies contiguous to the corporate boundaries of Richfield, Utah; and

WHEREAS, said owners have caused a petition to be filed with the City Recorder together with an accurate plat of the real property which was made under the supervision of a licensed surveyor; and

WHEREAS, Richfield City Council accepted the petition for annexation; and within 30 days the City Recorder reviewed the petition and certified that the petition meets the requirements for annexation as provided by Utah State Law (Subsections 10-2-408(2), (3), and (4)); and

WHEREAS, a notice was published once a week for three successive weeks, beginning no later than ten days after receipt of the notice of certification, in a newspaper of general circulation the area proposed for annexation and the unincorporated area within half mile of the area proposed for annexation as provided by Utah State Law (Subsection 10-2-406); and

WHEREAS, within 20 days of receipt of the notice of certification, written notices were mailed to the affected entities as provided by Utah State Law (Subsections 10-2-406(1) (b)); and

WHEREAS, no valid protests to the annexation petition were filed during the period specified;

NOW, THEREFORE, pursuant to Section 10-2-407, Utah Code, the City Council of Richfield, Utah, hereby adopts and passes the following:

BE IT ORDAINED BY THE CITY COUNCIL OF RICHFIELD, UTAH, AS FOLLOWS:

ORDINANCE 2008-14 ANNEXING CERTAIN REAL PROPERTY AND EXTENDING THE CORPORATE LIMITS OF RICHFIELD, UTAH.

The real property more particularly described in Paragraph 1, below, is hereby annexed to Richfield, Utah and the corporate limits of Richfield, Utah, are hereby extended accordingly.

1. BEGINNING AT THE SOUTHWEST CORNER OF SECTION 19, T.23 S., R.2 W., S.L.B. & M., SAID POINT BEING LOCATED ON THE EXISTING RICHFIELD CITY CORPORATE BOUNDARY; RUNNING THENCE N00°15'35"W 2695.69 FEET ALONG THE WEST LINE OF SAID SECTION 19 TO THE NORTHWEST CORNER OF TAX PARCEL 4-205-5; THENCE

N89°32'33"E 1009.98 FEET ALONG THE NORTH LINE OF SAID PARCEL TO THE NORTHWEST CORNER OF TAX PARCEL 4-205-34; THENCE S00°27'27"E 79.20 FEET ALONG THE WEST LINE OF SAID PARCEL TO THE SOUTHWEST CORNER OF THE SAME; THENCE N89°31'49"E 43.34 FEET ALONG THE SOUTH LINE OF SAID PARCEL TO THE EXTENSION OF THE EAST RIGHT-OF-WAY LINE OF A COUNTY ROAD; THENCE ALONG THE RIGHT-OF-WAY LINE (AND EXTENSION THEREOF) OF SAID COUNTY ROAD THE FOLLOWING SIX (6) COURSES AND DISTANCES: (1) S00°37'33"W 806.14 FEET, (2) S88°54'25"W 465.00 FEET, (3) S00°15'35"E 515.01 FEET, (4) N89°32'25"E 12.60 FEET, (5) S00°27'35"E 37.81 FEET, AND (6) S88°19'39"W 47.19 FEET TO A POINT ON THE WEST LINE OF TAX PARCEL 4-205-32; THENCE S00°27'35"E 265.97 FEET ALONG SAID WEST LINE TO THE SOUTHWEST CORNER OF SAID PARCEL; THENCE N89°32'25"E 298.38 FEET ALONG THE SOUTH LINE OF SAID PARCEL TO A POINT ON THE WEST LINE OF TAX PARCEL 4-205-3; THENCE S00°27'35"E 785.55 FEET ALONG SAID WEST LINE AND THE WEST LINE OF TAX PARCEL 4-205-2 TO A POINT ON THE NORTH LINE OF TAX PARCEL 4-205-35; THENDE S89°32'25"W 326.07 FEET ALONG SAID NORTH LINE TO THE NORTHWEST CORNER OF SAID PARCEL; THENCE S01°28'21"E 200.01 FEET ALONG THE WEST LINE OF SAID PARCEL TO THE SOUTH LINE OF SAID SECTION 19; THENCE S89°32'25"W 521.95 FEET ALONG SAID SECTION LINE TO THE POINT OF BEGINNING. CONTAINING 49.5 ACRES, MORE OR LESS. 4-205-5, 4-205-4, 4-205-29, 4-205-28, 4-205-36, 4-205-26, 4-205-37

- 2. The zoning map of Richfield City shall be amended to include the real property described in Paragraph 2. The real property described in Paragraph 2, above, shall be classified as being in single family residential (R1-10) and rural residential (RR-1), in accordance with the General Plan for Richfield, Utah, provisions of the City's Land Use Ordinance and Section 10-9-406(1) of the Utah Code Annotated, 1953, as amended.
- 3. A certified copy of this Ordinance and an original plat setting forth the property so annexed shall be filed with the County Recorder of Sevier County, Utah by the City Recorder.
- 4. This Ordinance shall become effective upon adoption and passage by the City Council. A copy of the Ordinance and plat shall be deposited in the Office of the City Recorder.

RESOLUTION NO. 2008-10

A RESOLUTION ACCEPTING A PETITION FOR ANNEXATION OF CERTAIN REAL PROPERTY UNDER THE PROVISIONS OF SECTIONS 10-2-403 AND 10-2-405, UTAH CODE ANNOTATED, 1953, AS AMENDED.

WHEREAS, on the 15th day of July, 2008 the owner of certain real property, Joseph Levine, Darren and Lana Barney, Fred and Jeneal Wingelaar, petitioners, filed a petition with the city recorder of Richfield City, Sevier County, State of Utah requesting that such property be annexed to the corporate boundaries of Richfield City; and

NOW THEREFORE, BE IT RESOLVED by the City Council of Richfield City, Sevier County, State of Utah, that the Annexation Petition, attached hereto as Exhibit "A" is hereby accepted for further consideration under the provisions of Utah State Annexation Law and is hereby referred to the city recorder for review pursuant to Section 10-2-405(2), Utah State Code Annotated, 1953, as amended.




ANNEXATION PLAT
