## JOINT NOTICE OF AGREEMENT TO CREATE THE DAVIS-SALT LAKE AERIAL SPRAY AUTHORITY, AN INTERLOCAL ENTITY

Pursuant to the provisions of the Interlocal Cooperation Act and particularly § 11-13-204(4) Utah Code Annotated, 1953, Salt Lake City Mosquito Abatement District and Mosquito Abatement District-Davis hereby give joint notice to the Lieutenant Governor that on October 31, 2008 the said Districts entered into an "Interlocal Cooperation Agreement establishing the Davis-Salt Lake Aerial Spray Authority" (the "Authority") for the purpose of creating an Interlocal Entity.

A copy of the Agreement creating the Authority is attached hereto.

The Salt Lake City Mosquito Abatement District and the Mosquito Abatement District-Davis jointly certify by authority of the Governing Body of each of said Districts that all necessary legal requirements relating to the creation of said Authority have been completed.
