HOOPER WATER IMPROVEMENT DISTRICT NOTICE OF BOUNDARY CHANGE (WITHDRAWAL) AND BOARD CERTIFICATION

TO: LIEUTENANT GOVERNOR OF THE STATE OF UTAH

NOTICE is hereby given that, on November 12, 2008, the Board of Trustees of the Hooper Water Improvement District (the "District") adopted a Resolution Approving Withdrawal (the "Withdrawal Resolution") The withdrawal will be effective upon your issuance of a certificate of boundary change, which is to be accomplished with ten days after receiving this notice as provided in UTAH CODE ANN. § 67-1a-6.5(7). The withdrawal is pursuant to applicable requirements of UTAH CODE ANN. §§ 17B-1-501 <u>et seq.</u>, all of which have been satisfied. From and after the effective date of the withdrawal, the affected area will no longer be part of the District.

The Board of Trustees of the Hooper Water Improvement District hereby certifies that all requirements for the withdrawal have been complied with. This certification is issued pursuant to the requirements of UTAH CODE ANN. § 17B-1-512(1)(b)(ii).

This notice is accompanied by: (a) a copy of the Withdrawal Resolution and (b) an accurate map depicting the boundaries of the withdrawn area and/or a legal description of the withdrawn area, adequate for purposes of the Weber County Assessor and the Weber County Recorder.

Please issue the certificate of boundary change and send a copy of the certificate to the District at the address provided in this notice, as well as to the government offices identified in UTAH CODE ANN. § 67-1a-6.5(7)(b).

RESOLUTION APPROVING WITHDRAWAL

WHEREAS, the Hooper Water Improvement District (the "District") owns and operates a water distribution system;

WHEREAS, real property identified as the "Ogden Clinic" is located within Roy City and also within the District;

WHEREAS, the owner of the Ogden Clinic property desires to receive culinary water service from Roy City and Roy City is willing to provide culinary water service to the Ogden Clinic property;

WHEREAS, the owner of the Ogden Clinic property, which is described in attached Exhibit "A" (the "Withdrawal Area"), recently submitted a petition to the District requesting that the Withdrawal Area be withdrawn from the District;

WHEREAS, pursuant to UTAH CODE ANN. § 17B-1-507(1), the petition has been certified by the District Board as satisfying the withdrawal petition requirements of UTAH CODE ANN. §§ 17B-1-504 and -506;

WHEREAS, since the petition was signed by the sole owner of the Withdrawal Area, a public hearing on the proposed withdrawal is not required;

WHEREAS, the Trustees of the District have concluded that it is equitable and fair for the Withdrawal Area to be withdrawn from the District without any requirement that the property owner make any payment in lieu of taxes, fees or assessments or pay any share of outstanding bonds or other obligations of the District but the owner has been required to reimburse to the District an itemized list of expenses, other than attorney fees, which expenses have been paid; and

WHEREAS, the District Board of Trustees deems it to be in the best interests of the District and its residents and customers, and of the Withdrawal Area, to withdraw from the District all of the Withdrawal Area in accordance with this Resolution.

NOW, THEREFORE, BE IT RESOLVED and enacted by the Board of Trustees of the Hooper Water Improvement District as follows:

- 1. That this Resolution is adopted for the purpose of fulfilling and complying with the requirements of UTAH CODE ANN. §§ 17B-1-501, et seq., relating to property being withdrawn from the District.
 - 2. That the Board of Trustees of the District has and hereby does determine that:

- (a) A water service commitment has been obtained from Roy City to serve the Withdrawal Area.
- (b) All required legal formalities, preparatory to the adoption of this Resolution, have been satisfied.
- (c) The proposed withdrawal appears to be equitable and necessary under the circumstances.
- 3. That the withdrawal of the real property described in attached Exhibit "A," which is incorporated by reference as part of this Resolution, is hereby approved pursuant to UTAH CODE ANN. § 17B-1-510.
- 4. That the withdrawal shall be effective upon the date that the Lieutenant Governor of the State of Utah issues a certificate of boundary change finalizing the withdrawal.
- 5. That, from and after the effective date of the withdrawal, the Withdrawal Area shall no longer be a part of the Hooper Water Improvement District or be taxable by the District.
- 6. That the General Manager of the District be and is authorized and instructed, within ten days after the adoption of this Resolution by the Board of Trustees, to file a written notice of withdrawal with the Lieutenant Governor and to file such other documents and take such other steps as may be necessary or appropriate to complete the withdrawal. The notice shall be accompanied by a copy of this Resolution and an accurate map depicting the boundaries of the Withdrawal Area and/or a legal description of the Withdrawal Area adequate for the purposes of the Weber County Assessor and the Weber County Recorder.
 - 7. That there are no special conditions to this withdrawal.
- 8. That, within 60 days after adoption of this Resolution, any person in interest may seek judicial review of the Board of Trustees' decision to withdraw the area described and/or depicted in attached Exhibit "A" or the terms and conditions of the withdrawal, in accordance with the requirements of UTAH CODE ANN. § 17B-1-512(6). As provided in UTAH CODE ANN. § 17B-1-512(7), after the applicable contest period under the statute, no person may contest the Board of Trustees' approval of the withdrawal for any cause.
- 9. That this Resolution has been placed on the agenda of a meeting of the Board of Trustees of the District, which meeting was not later than the next meeting of the Board following the meeting during which the Withdrawal Petition was certified, and this action is taken in compliance with the Utah Open and Public Meetings Act.

10. That this Resolution shall take effect upon its approval and adoption by the Board of Trustees, but the withdrawal shall not be complete until the date on which the Lieutenant Governor issues a certificate of boundary change as provided in paragraph 4 above.


The Withdrawal Area is located in Weber County, Utah and is more particularly described as follows:
