GRANTSVILLE CITY ORDINANCE 2008-36

AN ORDINANCE OF GRANTSVILLE CITY, A MUNICIPAL CORPORATION OF THE STATE OF UTAH, ANNEXING INTO ITS CORPORATE CITY LIMITS 29.21 ACRES OF REAL PROPERTY LOCATED ADJACENT TO THE WEST BOUNDARY OF GRANTSVILLE CITY.

(Nadine Hunt Petition)

WHEREAS, the Grantsville City Council has received and considered a petition for the annexation of 29.21 acres of real property located along the existing west corporate boundary of the City and directly south of Mack Canyon Road; and

WHEREAS, no protests of the annexation petition have been filed; and

WHEREAS, the Grantsville City Council has conducted a public hearing on this proposed annexation, after proper notice and has considered any comments made at the public hearing; and

WHEREAS, the Grantsville City Council finds that this annexation petition will promote the best interests of the City, including the health, safety and welfare of its residents.

NOW, THEREFORE, BE IT ORDAINED BY THE GRANTSVILLE CITY COUNCIL, that the Annexation Petition dated April 28, 2008 and filed by Nadine Hunt and Randy Hunt, is hereby granted. The following described real property located in Tooele County, State of Utah is hereby annexed into the corporate boundaries of Grantsville City, a municipal corporation of the State of Utah and the inhabitants and property owners thereof shall enjoy all of the privileges of Grantsville City upon the effective date of this ordinance:

A parcel of land, situate in the Northeast Quarter of Section 34, Township 2 South, Range 6 West, Salt Lake Base and Meridian, also located in Tooele County, Utah and more particularly described as follows: Beginning at a point on the Section line, which is located North 89°43'11" East 661.07 feet along the Section line from the North Quarter Corner of Section 34, Township 2 South, Range 6 West, Salt Lake Base and Meridian, and running thence North 89°43'11" East 963.40 feet along the Section line to the Grantsville City limits; thence South 0°20'04" East 1321.28 feet along said city limits and along and through several fence lines and found bar and caps to an existing fence line; thence South 89°43'49" West 962.90 feet along said fence line to its intersection with another existing fence line; thence North 0°21'23" West 1321.10 feet along said fence line to the point of beginning, containing 1,272,503 square feet.

The appropriate City Officers are hereby authorized and directed to execute the annexation plat that was presented as a part of the annexation petition and within 30 days of the enactment of this ordinance, send notice of this annexation to each affected entity including the North Tooele County Fire Protection Service District, record with the Tooele County Recorder a certified copy of this ordinance together with the annexation plat and file with the Lieutenant Governor of the State of Utah a certified copy of this ordinance, a copy of the approved annexation plat with evidence that it was recorded by the Tooele County Recorder and filed with the Tooele County Surveyor in accordance with Utah Code Ann. §17-23-17, together with the required certification and written notice of the adoption of this ordinance. Also in accordance with Utah Code Ann. §10-1-116 the appropriate City Officers shall provide notice of this annexation to the State Tax Commission accompanied with a copy of this ordinance, a copy of the annexation plat with evidence that the plat was recorded by the Tooele County Recorder and the required Certification of the Grantsville City Council.

The property that is the subject of this annexation ordinance is hereby designated and assigned an A-10 (Agricultural - 10 Acre Minimum Lot Size) zoning designation as defined by the Grantsville Land Use Management and Development Code and the official zoning map of Grantsville City is amended by the inclusion of the above described parcel with said A-10 designation.

This Ordinance shall take effect upon the date of the Lieutenant Governor's issuance of a certificate of annexation under Utah Code Ann. §10-2-425(5)(b), provided a short summary of this ordinance has been also been published in a newspaper of general circulation within Grantsville City,

NOTICE OF ADOPTION OF ANNEXATION ORDINANCE AND BOUNDARY CHANGE

Pursuant to the provisions of Utah Code Ann. §10-2-425 and §10-1-116, the Grantsville City Council hereby gives notice to the Lieutenant Governor of the State of Utah, that the boundaries of Grantsville City, a municipal corporation of the State of Utah, have been changed through the annexation of approximately 29.21 acres of property into the corporate limits of Grantsville City. The property annexed is located in Tooele County, State of Utah and is described as follows:

A parcel of land, situate in the Northeast Quarter of Section 34, Township 2 South, Range 6 West, Salt Lake Base and Meridian, also located in Tooele County, Utah and more particularly described as follows: Beginning at a point on the Section line, which is located North 89°43'11" East 661.07 feet along the Section line from the North Quarter Corner of Section 34, Township 2 South, Range 6 West, Salt Lake Base and Meridian, and running thence North 89°43'11" East 963.40 feet along the Section line to the Grantsville City limits; thence South 0°20'04" East 1321.28 feet along said city limits and along and through several fence lines and found bar and caps to an existing fence line; thence South 89°43'49" West 962.90 feet along said fence line to its intersection with another existing fence line; thence North 0°21'23" West 1321.10 feet along said fence line to the point of beginning, containing 1,272,503 square feet.

Accompanying this Notice is a certified copy of the Ordinance that effectuated this annexation and boundary change, together with a plat prepared by a licensed surveyor which has been approved by the Grantsville City Council, together with evidence showing that this annexation plat has been recorded with the Tooele County Recorder and filed with the Tooele County Surveyor.

Pursuant to Utah Code Ann. §26-8a-414, the Grantsville City Council certifies that Grantsville City does not provide ambulance or paramedic services within its corporate limits and therefore does not desire to provide such services to the property annexed into Grantsville City.
