ORDINANCE NO. <u>**O-2008-04**</u>

AN ORDINANCE ANNEXING AN AREA OF 24.6 ACRES
COMMONLY KNOWN AS THE BUHLER ANNEXATION AND
AMENDING THE ARTICLES OF INCORPORATION
OF HIGHLAND CITY

WHEREAS, on the 5th day of February, 2008, the City Council of Highland, Utah, according to the law, approved the annexation of certain territory contiguous to the boundary of said City; and

WHEREAS, the laws of the State of Utah provide that the Articles of Incorporation of the City be amended with respect to its geographical description by adding thereto the territory so annexed;

WHEREAS, all public hearings and notices have been completed as a prerequisite to amending the General Plan of the City to include the annexed property and to zone the land proposed for annexation for residential use;

WHEREAS, the City may establish a zone designation at the time of annexation pursuant to Utah Code Section 10-9-406;

NOW, THEREFORE, be it ordained by the City Council of Highland, Utah, that:

1. The Articles of Incorporation of the City are hereby amended with respect to the geographical description of the City found therein by adding thereto the following described annexed territory.

Beginning at a point located North 89°59'15" East along section line 711.92 feet and South 30.03 feet from the North quarter corner of Section 2, Township 5 South, Range 1 East, Salt Lake Base and Meridian; thence along the existing Highland City Boundary the following four courses and distances: 1) North 89°59'14" East 623.36 feet, 2) South 1303.05 feet, and 3) South 89°48'00" West 1085.28 feet, and 4) North 544.02 feet; thence North 89°29'00" East 443.78 feet to a fence line; thence along said fence line and a boundary line agreement (Entry #39493:2005) the following five courses and distances: 1) North 01°31'28" East 122.40 feet 2) North 01°15'20" East 237.32 feet, 3) North 00°08'18" East 165.53 feet, 4) North 02°18'38" East 230.75 feet, and 5) North 2.97 feet to the point of beginning. An area containing 24.6182 acres.

2. The newly annexed territory shall all have the zone designation of R-1-40. Highland City is a City of the Fourth Class as defined in Utah Code Annotated, Sec. 10-2-301(2)(d) having a population of more than 10,000 or more but less than 30,000 inhabitants.

- 3. A certified copy of this Ordinance and an original plat describing the property so annexed, shall be filed with the Utah County Recorder within thirty (30) days after the date this Ordinance is adopted.
- 4. Amended Articles of Incorporation shall be filed with the Utah Lieutenant Governor's office as required by law.
- 5. A certified copy of this Ordinance, an original plat describing the property annexed and a Notice of Annexation pursuant to Utah Code Ann. §10-1-116, shall be filed with the Utah State Tax Commission within forty-five (45) days after the date this Ordinance is adopted.
- 6. This Ordinance shall be effective on the date of its first posting or publication, whichever occurs first.
- 7. The Mayor or the designee of the Mayor is authorized to notify and implement this annexation with respect to local, county and state governmental entities.
