EXHIBIT A

ORDINANCE NO. 0-23-2008

AN ORDINANCE ADJUSTING THE COMMON BOUNDARIES BETWEEN THE CITY OF SARATOGA SPRINGS AND EAGLE MOUNTAIN CITY AND PROVIDING FOR AN EFFECTIVE DATE

PREAMBLE

The City Council of Eagle Mountain City finds that, *Utah Code Ann.* § 10-2-419 establishes a procedure for adjustment of the common boundaries between adjacent municipalities.

The City of Saratoga Springs shares certain common boundaries with Eagle Mountain City and the City of Saratoga Springs and Eagle Mountain City have each received a request from the owner of real property within the City of Saratoga Springs but contiguous to Eagle Mountain City that the owner's property be transferred from the municipal jurisdiction of the City of Saratoga Springs to Eagle Mountain City.

The City Council of Eagle Mountain City approved Resolution No. R 25-2008 on August 19, 2008 stating its intent to adjust its common boundary with the City of Saratoga Springs.

The City Council of Eagle Mountain City received no written protests to the proposed boundary adjustment by the deadline for receiving written protests, and held a public hearing on October 21, 2008 to consider approving the proposed boundary adjustment and received public comment on the proposed boundary adjustment.

The required public hearing was advertised as required by *Utah Code Ann.* § 10-2-419 and no protests were received by the Eagle Mountain City protesting the proposed boundary adjustment.

The proposed boundary adjustment is in the public interest.

BE IT ORDAINED BY THE CITY COUNCIL OF EAGLE MOUNTAIN CITY:

1. The City Council acknowledges receipt of a written request from the owner of the real property hereinafter described requesting that its property be transferred from the municipal jurisdiction of the City of Saratoga Springs and annexed to Eagle Mountain City in accordance with the terms of *Utah Code Ann.* § 10-2-419. The legal description of the land to be removed from the municipal jurisdiction of the City of Saratoga Springs and annexed to Eagle Mountain City is set forth below:

Beginning at a point located North 89°00'48" West along Section line 1849.57 feet and North 70.53 feet from the South quarter corner of Section 16. Township 5 South. Range 1 West. Salt Lake Base and Meridian: thence North 78°10'00" East along State Road 73 a distance of 1664.82: thence South 33°57'46" West 2934.11 feet to the point of beginning



Acres 39.092 (58:033:0154, 58:033:0210, 58:033:0283, and 58:033:0285) less and excepting lands located within Eagle Mountain City.

- 2. The City Council of Eagle Mountain City takes notice of the enactment of an Ordinance by the City Council of the City of Saratoga Springs approving the proposed boundary adjustment to include the land described in paragraph 1 above within Eagle Mountain City. The municipal boundary of Eagle Mountain City is hereby extended to annex the land described in paragraph 1. The Mayor, Recorder and staff of Eagle Mountain City are hereby authorized to execute and file such notices, amended articles of incorporation, maps and all documents required under the provisions of Section 10-2-425, Utah Code, to complete the boundary adjustment and annexation of the land described in paragraph 1 to Eagle Mountain City.
- 3. This ordinance shall take effect upon its passage and after being posted or published as required by law.


