ORDINANCE 2008-16

AN ORDINANCE, PURSUANT TO SECTION 10-2-502.5, UTAH CODE ANNOTATED, DISCONNECTING CERTAIN PROPERTY FROM THE CITY LIMITS OF MIDWAY CITY.

WHEREAS, Section 10-2-502.5, Utah Code Annotated, allows a city to disconnect certain areas from the city limits of the city; and

WHEREAS, a petition has been filed with Midway City to disconnect from the Midway City limits the area described on Exhibit A attached hereto; and

WHEREAS, Midway City has held all required public hearings and given all required public notice of the proposed disconnection; and

WHEREAS, the Midway City Council has determined that it is in the public interest to grant the proposed disconnection from the Midway City limits.

NOW THEREFORE, pursuant to Section 10-2-502.5, Utah Code Annotated, the City Council of Midway City hereby enacts the following:

The property described on Exhibit A attached hereto is hereby disconnected from the Midway City limits and is no longer included within Midway City.
