ORDINANCE NO. 2007-17

AN ORDINANCE DECLARING THE ANNEXATION OF TERRITORY TO THE MUNICIPALITY OF NORTH OGDEN CITY. THE PROPERTY IS ONE PARCEL TOTALING 6.394 ACRES OWNED BY STOREY-HANSEN INV., LLC AND IS LOCATED NORTH EAST OF THE NORTH OGDEN DIVIDE AT 1550 EAST.

WHEREAS, Storey-Hansen Inv., LLC., own property within the North Ogden City limits; and

WHEREAS, Storey-Hansen Inv., LLC, desire to have their property annexed into the corporate limits of North Ogden City; and

WHEREAS, Storey-Hansen Inv., LLC., submitted a petition with an accurate plat or map of the territory to be annexed prepared under the supervision of the city engineer or a competent surveyor and certifies by the engineer or surveyor; and

WHEREAS, Storey-Hansen Inv., LLC., own the land petitioned to be annexed into the City; and

WHEREAS, The Chairman of the planning commission of the township where Storey-Hansen Inv., LLC., has been notified of this annexation petition; and

WHEREAS, The Weber County Clerk/Auditor was notified on August 7, 2007 of the Storey-Hansen Inv., LLC., annexation petition;

IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF NORTH CITY:

SECTION 1. <u>TERRITORY ANNEXED</u>. The following legally described

A PARCEL OF LAND LOCATED IN SECTION 27, TOWNSHIP 7 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 27, TOWNSHIP 7 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, AND RUNNING THENCE NORTH 00°51'54" EAST, ALONG THE SECTION LINE, A DISTANCE OF 5285.79 FEET, TO THE NORTHWEST CORNER OF SAID SECTION 27; THENCE SOUTH 88°38'15" EAST, ALONG THE SECTION LINE, A DISTANCE OF 2649.22 FEET, TO THE NORTH QUARTER CORNER OF SAID SECTION 27; THENCE SOUTH 89°12'16" EAST, ALONG THE SECTION LINE, A DISTANCE OF 200.00

FEET, TO THE POINT OF BEGINNING FOR THIS DESCRIPTION; THENCE SOUTH 89°12'16" EAST, ALONG THE SECTION LINE, A DISTANCE OF 256.54 FEET, TO A POINT ON THE WEST LINE OF A POWER CORRIDOR; THENCE SOUTH 26°01'07" EAST, ALONG SAID POWER CORRIDOR, A DISTANCE OF 736.87 FEET, TO A POINT ON THE NORTH LINE OF THE SOUTH HALF OF THE NORTH HALF OF THE NORTHEAST QUARTER OF SAID SECTION 27; THENCE NORTH 89°10'34" WEST, ALONG SAID NORTH LINE, A DISTANCE OF 590.79 FEET, TO A POINT LYING 200 FEET EASTERLY OF THE NORTH-SOUTH CENTER QUARTER LINE OF SAID SECTION 27, SAID POINT LYING ON THE EXISTING NORTH OGDEN CITY BOUNDARY; THENCE NORTH 00°57'24" EAST, PARALLEL WITH SAID CENTER QUARTER LINE AND THE EXISTING NORTH OGDEN CITY BOUNDARY, A DISTANCE OF 657.35 FEET, TO THE POINT OF BEGINNING.

SECTION 2. Zoning Classification:

All the area being annexed is zoned R-1-12.5.

SECTION 3. Effective date:

This ordinance shall take effect upon the recording of the Annexation plat.
