AN ORDINANCE DECLARING THE ANNEXATION OF TERRITORY TO THE MUNICIPALITY OF NORTH OGDEN CITY. THE PROPERTY IS ONE PARCEL TOTALING 11.06 ACRES OWNED BY BRENT BAILEY, ETHAN T. HEAP, GENE STEPHENS, JOHN W. HANSEN, AND JOHN L. WATSON AND IS LOCATED SOUTH OF 2550 NORTH AT 200 EAST.

WHEREAS, Brent Bailey, Ethan T. Heap, Gene Stephens, John W. Hanson, and John L. Watson, own property within the North Ogden City limits; and

WHEREAS, Brent Bailey, Ethan T. Heap, Gene Stephens, John W. Hanson, and John L. Watson, desire to have their property annexed into the corporate limits of North Ogden City; and

WHEREAS, Brent Bailey, Ethan T. Heap, Gene Stephens, John W. Hansen, and John L. Watson, submitted a petition with an accurate plat or map of the territory to be annexed prepared under the supervision of the city engineer or a competent surveyor and certifies by the engineer or surveyor; and

WHEREAS, Brent Bailey, Ethan T. Heap, Gene Stephens, John W. Hansen, and John L. Watson, own the land petitioned to be annexed into the City; and

WHEREAS, The Chairman of the planning commission of the township where Brent Bailey, Ethan T. Heap, Gene Stephens, John W. Hansen, and John L. Watson, has been notified of this annexation petition; and

WHEREAS, The Weber County Clerk/Auditor was notified on February 29, 2008 of the Brent Bailey, Ethan T. Heap, Gene Stephens, John W. Hansen and John L. Watson, annexation petition;

IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF NORTH CITY:

SECTION 1. TERRITORY ANNEXED. The following legally described

ALONG SAID SOUTH RIGHT-OF-WAY LINE OF 2550 NORTH STREET TO THE WEST RIGHT-OF-WAY LINE OF 200 EAST STREET BEING THE **EXISTING NORTH OGDEN CITY CORPORATE BOUNDARY;** THENCE SOUTH 01°09'14" WEST 1160.22 FEET (SOUTH 00°15" WEST 1155.00 FEET B.R.) ALONG SAID EXISTING CORPORATE **BOUNDARY AND SAID WEST RIGHT-OF-WAY LINE TO THE** NORTH LINE OF PARCEL 180560058; THENCE NORTH 88°55'51" WEST 298.92 FEET (WEST 300.00 FEET B.R.) ALONG THE SAID NORTH LINE OF PARCEL 180560058 AND SAID EXISTING CORPORATE BOUNDARY LINE TO THE NORTHWEST CORNER OF SAID PARCEL 180560058; THENCE SOUTH 01°09'14" WEST 823.02 FEET (SOUTHERLY 810.00 FEET B.R.) ALONG THE WEST LINE OF SAID PARCEL 180560058 AND SAID EXISTING CORPORATE BOUNDARY TO THE NORTH LINE OF PARCEL 170680011; THENCE NORTH 88°55'51" WEST 68.05 FEET ALONG THE SAID NORTH LINE OF PARCEL 170680011; THENCE NORTH 01°09'14" EAST 1984.16 FEET TO THE BEGINNING. **CONTAINING 11.06 ACRES**
