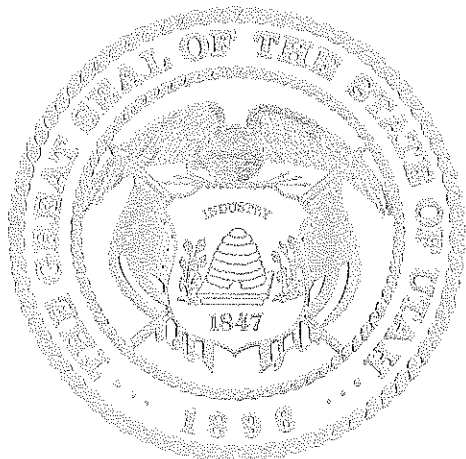

ORDINANCE NO. 993

**AN ORDINANCE ESTABLISHING A ZONE FOR THE
JANICE B. OLSEN AND JERRY E. OLSEN, STANGER'S GREENHOUSE AND
GARDEN SUPPLY, L.L.C., AND RAY E. WELCHMAN AND IVA LOO WELCHMAN
PROPERTIES WHICH HAVE BEEN ANNEXED INTO ROY CITY**

WHEREAS, Roy City Ordinance requires the Roy City Council to establish a zone for property which is annexed into Roy City, and property owned by Janice B. Olsen and Jerry E. Olsen, Stanger's Greenhouse and Garden Supply, L.L.C., and Ray E. Welchman and Iva Loo Welchman has been approved to be annexed into Roy City; and

WHEREAS, the Janice B. Olsen and Jerry E. Olsen, Stanger's Greenhouse and Garden Supply, L.L.C., and Ray E. Welchman and Iva Loo Welchman properties are contiguous to Roy City boundaries.

NOW, THEREFORE, Be it hereby resolved by the City Council of Roy City, Utah, that the following described properties be zoned as Community Commercial as follows:

A part of the Northwest Quarter of Section 22, Township 5 North, Range 2 West, Salt Lake Base and Meridian, U.S. Survey, Weber County, Utah:

Beginning at a point located 206.1 feet North 89°45'44" West along the Section Line from the Northeast Corner of the Northwest Quarter of the Northwest Quarter of said Section 22; and running thence South 0°14'12" West 629.57 feet (635.00 feet record) along a Westerly City Limit Line to a Northerly City Limit Line and the North Line of the Home Depot U.S.A., Inc. Property; thence North 89°39'51" West 480.91 feet along said Northerly City Limit Line to an Easterly City Limit Line; thence North 0°14'12" East 628.74 feet (635.00 feet record) along said Easterly City Limit Line to the Section Line; thence South 89°45'44" East 480.90 feet along the Section Line to the point of beginning.

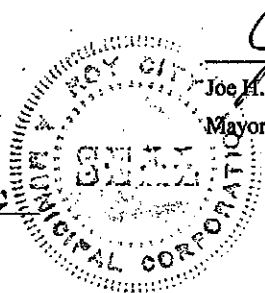

RESOLUTION NO. 918

A RESOLUTION APPROVING THE ANNEXATION OF THE
JANICE B. OLSEN AND JERRY E. OLSEN, STANGER'S GREENHOUSE AND GARDEN SUPPLY, L.L.C., AND
RAY E. WELCHMAN AND IVA LOO WELCHMAN PROPERTIES

WHEREAS, the Roy City Council has duly considered the petition for annexation executed by
Janice B. Olsen and Jerry E. Olsen, Stanger's Greenhouse and Garden Supply, L.L.C.,
and Ray E. Welchman and Iva Loo Welchman and after having held the necessary public
hearings thereon and it appearing that it is in the best interests of Roy City and
the petitioning property owners that this annexation be approved; and

WHEREAS, this annexation includes portions of an unincorporated island within Roy City, and
the City Council finds that leaving the remainder of the island unincorporated is
in the best interests of the City at this time, and this annexation lessens an
existing island.

NOW, THEREFORE, Be it hereby resolved by the Roy City Council of Roy City, Utah, that the
following-described property be and hereby is annexed and is to be included within
the boundaries of Roy City:

A part of the Northwest Quarter of Section 22, Township 5 North, Range 2 West, Salt
Lake Base and Meridian, U.S. Survey, Weber County, Utah:

certified copy of this Resolution declaring the annexation.
