RESOLUTION NO. 905

A RESOLUTION APPROVING THE ANNEXATION OF THE CHARMA L. RICHARDSON, ROBERT AND ROMA LEGGETT, KEITH AND JESSICA MOULDING, JOY E. MOWER, CASEY D. AND KIMBERLEE MARKER, JAMES H. KITCHEN, AND ROBERT AND ARLENE BECK PROPERTIES

WHEREAS, the Roy City Council has duly considered the petition for annexation executed by Charma L. Richardson, Robert and Roma Leggett, Keith and Jessica Moulding, Joy E. Mower, Casey D. and Kimberlee Marker, and James H. Kitchen and after having held the necessary public hearings thereon and it appearing that it is in the best interests of Roy City and the petitioning property owners that this annexation be approved; and

WHEREAS, this annexation includes portions of an unincorporated island within Roy City, and the City Council finds that leaving the remainder of the island unincorporated is in the best interests of the City at this time, and this annexation lessens an existing island.

NOW, THEREFORE, Be it hereby resolved by the Roy City Council of Roy City, Utah, that the following-described property, including the Robert and Arlene Beck property, be and hereby is annexed and is to be included within the boundaries of Roy City:

PART OF THE SOUTHEAST QUARTER OF SECTION 3, T5N, R2W, SLB&M: BEGINNING AT THE SOUTHEAST CORNER OF SAID SECTION 3, AND RUNNING THENCE NORTH 452 FEET, THENCE WEST 548.55 FEET, MORE OR LESS, TO THE WESTERLY RIGHT-OF-WAY LINE OF MIDLAND DRIVE, THENCE SOUTHWESTERLY 592.77 FEET MORE OR LESS, ALONG SAID RIGHT-OF-WAY TO THE SOUTH LINE OF SAID QUARTER SECTION, THENCE EAST ALONG SAID SECTION 932.04 FEET, MORE OR LESS, TO THE POINT OF BEGINNING. CONTAINING 334,614 SQ FT/7.68 ACRES MORE OR LESS.

Be it further provided that a copy of the duly certified plat or map of the annexing property be filed in the Office of the Weber County Recorder, together with a certified copy of this Resolution declaring the annexation.

Be it further resolved that a copy of the Resolution be forwarded to the necessary taxing entities and other entities as required by law.

ORDINANCE NO. 984

AN ORDINANCE ESTABLISHING A ZONE FOR THE CHARMA L. RICHARDSON, ROBERT AND ROMA LEGGETT, KEITH AND JESSICA MOULDING, JOY E. MOWER, CASEY D. AND KIMBERLEE MARKER, JAMES H. KITCHEN, AND ROBERT AND ARLENE BECK PROPERTIES WHICH HAVE BEEN ANNEXED INTO ROY CITY

WHEREAS, Roy City Ordinance requires the Roy City Council to establish a zone for property which is annexed into Roy City, and property owned by Charma L. Richardson, Robert and Roma Leggett, Keith and Jessica Moulding, Joy E. Mower, Casey D. and Kimberlee Marker, James H. Kitchen, and Robert and Arlene Beck, hereinafter referred to as the "Richardson, etc. property," has been approved to be annexed into Roy City; and

WHEREAS, the Richardson, etc. property is contiguous to Roy City boundaries.

NOW, THEREFORE, Be it hereby resolved by the City Council of Roy City, Utah, that the following described properties be zoned as Community Commercial as follows:

PART OF THE SOUTHEAST QUARTER OF SECTION 3, T5N, R2W, SLB&M: BEGINNING AT THE SOUTHEAST CORNER OF SAID SECTION 3, AND RUNNING THENCE NORTH 452 FEET, THENCE WEST 548.55 FEET, MORE OR LESS, TO THE WESTERLY RIGHT-OF-WAY LINE OF MIDLAND DRIVE, THENCE SOUTHWESTERLY 592.77 FEET MORE OR LESS, ALONG SAID RIGHT-OF-WAY TO THE SOUTH LINE OF SAID QUARTER SECTION, THENCE EAST ALONG SAID SECTION 932.04 FEET, MORE OR LESS, TO THE POINT OF BEGINNING. CONTAINING 334,614 SQ FT/7.68 ACRES MORE OR LESS.
