AN ORDINANCE DECLARING THE ANNEXATION OF TERRITORY TO THE MUNICIPALITY OF NORTH OGDEN CITY. THE PROPERTY IS ONE PARCEL TOTALING 9.50 ACRES OWNED BY MARVIN BARKER INVESTMENT COMPANY LLC, DAVID P. HOWELLS AND CAROLE G. HOWELLS AND IS LOCATED WEST OF 400 EAST BETWEEN 2600 NORTH AND 2550 NORTH.

- WHEREAS, Marvin Barker Investment Company LLC, David P. Howells, and Carole G. Howells own property within the North Ogden City limits; and
