ANNEXING REAL **PROPERTY** AN ORDINANCE LOCATED APPROXIMATELY 2525 NORTH FAIRFIELD ROAD INTO THE CITY AND EXTENDING THE CORPORATE LIMITS OF THE CITY.

WHEREAS, a petition in writing requesting the annexation to Layton City of certain real property, signed by a majority of the owners and by the owners of not less than one-third in value of said real property, as shown by the last assessment rolls, has been filed with the Layton City Recorder; and

WHEREAS, said petition was accompanied by a plat of said real property made under the supervision of a competent surveyor, showing the size and location of said real property and showing that the same is contiguous to the present corporate limits of Layton City; and

WHEREAS, said annexation area is contiguous to Layton City; and

WHEREAS, all notices required under Chapter 2 of Title 10, Utah Code, have been given, and the required protest period has expired and no protests to said annexation petition have been filed; and

WHEREAS, the Layton City Council deems it to be in the best interest of the City and its citizens to annex the real property described herein to Layton City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF LAYTON, **UTAH:** 

SECTION I: That the following described real property is hereby annexed to Layton City, and the corporate limits of the city are hereby extended to include said real property:

BEGINNING at a point on the east line of Fairfield Road said point also being on a old fence called for at Book 405 on Page 605; said point being located south 00\^06\'53\'' west 67.36 feet and west 123.84 feet from the west quarter corner of Section 10, T4N, R1W, Salt Lake Base & Meridian, and running thence north 00^20'50" east along said east line 184.72 feet; thence south 89^23'21" east 321.96 feet; thence North 99.58 ft; thence south 81<sup>2</sup>9'00" east 295.19 feet; thence north 01<sup>2</sup>2'00" east 131.62 feet to a point on an existing fence; thence south 89<sup>32</sup>21" east along said fence 753.46 feet to the west line of Wyndom Highlands No.1 as recorded with the Office of the Davis County Recorder: thence south 00\^00'43" east along said west line 376.98 feet to said old fence; thence north 89<sup>24</sup>'07" west along said old fence 1371.73 feet to the point of beginning.

Contains 420,946 sq. ft. 9.66 Acres

SECTION II: That the City Recorder is directed to file a certified copy of the plat of said real property and a certified copy of this ordinance of annexation with the Davis County Recorder.

SECTION III: Effective Date. This ordinance shall go into effect at the expiration of the 20th day after publication or posting or the 30th day after final passage as noted below or whichever of said days is the most remote from passage thereof.
