ORDINANCE NO. 06-17-2009A

AN ORDINANCE ANNEXING SKELLY'S PROPERTY TO ELMO, UTAH

PREAMBLE

The Town Council of Elmo Town finds that the owners of the real property described herein petitioned for annexation of the real property to the corporate limits of Elmo Town and that all required notices were given and provided to affected entities and others as required by law.

The real property described herein is an unincorporated area contiguous to the current boundary of Elmo Town and the annexation will not leave or create an unincorporated island or peninsula.

The Town Council finds that it is in the public interest to annex the real property to Elmo Town and has caused a plat of the real property to be prepared by a licensed surveyor.

After public comment and careful consideration, the Town Council has determined to annex the referenced property and therefore, finds that it should grant a petition for annexation with respect to the real property described herein.

BE IT ORDAINED by the Town Council of Elmo Town, Utah:

- 1. The real property described on the attached annexation plate, referenced as Exhibit A is hereby annexed to Elmo Town and the corporate limits of Elmo Town are hereby amended and extended to incorporate the real property described herein.
- 2. A certified copy of this ordinance and an original plat describing the property so annexed shall be filed with Emery County Recorder within (30) days after the date this ordinance is adopted.
- 3. Amended Articles of Incorporation shall be filed with the Utah Lieutenant Governor's office as required by law.
- 4. A certified copy of this ordinance, an original plat describing the property annexed and a Notice of Annexation pursuant to Utah Code Ann. 10-1-116, shall be filed with the Utah State Tax Commission within forty-five (45) days after the date this ordinance is adopted.
- 5. This ordinance shall be effective on the date of its first publication.

6. The Mayor or the designee of the Mayor is authorized to notify and implement this annexation with respect to local, county and state governmental entities.
