CERTIFICATE OF ANNEXATION



ORDINANCE 2008-04

(NATHAN AND MELISSA BLACKNER ANNEXATION)

WHEREAS, the owners of certain real property, described below, desire to annex such real property to the corporate limits of Annabella Town, Utah; and

WHEREAS, said real property is located within the area proposed for annexation and covers a majority of the private land area within the area proposed for annexation; and

WHEREAS, said real property is contiguous, unincorporated area contiguous to the boundaries of Annabella Town and the annexation thereof will not leave or create an unincorporated island or peninsula; and

WHEREAS, said owner have caused a Petition for Annexation to be filed with the town, together with an accurate plat of the real property which was made under the supervision of a competent, licensed surveyor; and

WHEREAS, on July 11, 2008 the Annabella Town Council received the required Notice of Certification from the Town Recorder certifying that the annexation petition meets the requirements of the State law; and

WHEREAS, the Town Council held the required public hearing after giving notice as required by law, and has determined the referenced annexation as desirable;

NOW THEREFORE, pursuant to Section 10-2-407, Utah Code Annotated 1953, as amended, the Town Council of Annabella Town, Utah, hereby adopts, passes, and publishes the following:

AN ORDINANCE AMENDING THE MUNICAPAL ZONING MAP, ANNEXING CERTAIN REAL PROPERTY AND EXTENDING THE CORPORATE LIMITS OF ANNABELLA TOWN, UTAH.

BE IT ORDAINED, by the Town Council of Annabella Town, Sevier County, State of Utah, as follows:

- 1. The real property, more particularly described in Paragraph 2, below, is hereby annexed into Annabella Town, Utah, and the corporate limits of the Town are hereby extended accordingly.
- 2. The real property which is the subject of the Ordinance is described as follows:

BEGINNING AT THE POINT ON NORTH LINE OF TOWN LIMITS 20 CHAINS NORTH AND 0.75 CHAINS WEST OF THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 24 SOUTH, RANGE 2

WEST, SALT LAKE BASE AND MERIDIAN; THENCE WEST 427 FEET; THENCE NORTH 74.78 FEET; THENCE EAST 427 FEET; THENCE SOUTH 74.78 FEET TO BEGINNING.

HAVING AN AREA OF 0.733 ACRES

- 3. The real property described in Paragraph 2, above, shall be classified as being in the residential R-1-5 zone in accordance with the provisions of the Annabella Land Use Ordinance and Zoning Map of Annabella Town which map is hereby amended to include the real property described above.
- 4. A certified copy of this Ordinance and the original plat describing the property so annexed shall be filed with the Sevier County Recorder.
- 5. This ordinance shall be effective upon the posting copies in three (3) public places within the corporate limits of Annabella Town.

Adopted the 14th day of August, 2008 by unanimous vote of the Annabella Town Council.
