AN ORDINANCE ANNEXING SPECIFIC PROPERTY TO NAPLES, UTAH.

WHEREAS, a majority of the owners of certain real property described below, desire to annex such real property to Naples, Utah, said owners being the owners of at least one-third (1/3) in value of said real property as shown by the last assessment roll; and

WHEREAS, said real property consists of approximately sixty-nine and sixteen tenths (69.16) acres and lies contiguous to the corporate boundaries of Naples, Utah; and

WHEREAS, said owners have cause a petition to be filed with the City Recorder together with an accurate plat of the real property which was made under the supervision of a licensed surveyor; and

WHEREAS, Naples City Council accepted the petition for annexation; and within thirty (30) days the City Recorder reviewed the petition and certified that the petition meets the requirements for annexation as provided by Utah State Law (Subsections 10-2-403(2),(3), and (4)); and

WHEREAS, a notice was published once a week for three successive weeks, beginning no later than ten days after receipt of the notice of certification, in a newspaper of general circulation, the area proposed for annexation and the unincorporated are withing ½ mile of the area proposed for annexation as provided by Utah State Law (Subsections 10-2-406); and

WHEREAS, within twenty (20) days of the receipt of the notice of certification, written notices were mailed to the affected entities as provided by Utah State Law (Subsections 10-2-406(1)(b)); and

WHEREAS, no protests to the annexation petition were filed during the period specified;

NOW, THEREFORE, pursuant to Section 10-2-407, Utah Code, the City Council of Naples, Utah, hereby adopts and passes the following:

BE IT ORDAINED BY THE CITY COUNCIL OF NAPLES, UTAH, AS FOLLOWS:

ORDINANCE ANNEXING CERTAIN REAL PROPERTY AND EXTENDING THE CORPORATE LIMITS OF NAPLES, UTAH.

- 1. The real property more particularly described in Paragraph 2, below is hereby annexed to Naples, Utah, and the corporate limits of Naples, Utah, are hereby extended accordingly.
- 2. The real property which is the subject of the Ordinance is described as follows:

FEET TO A POINT ON THE EAST LINE OF HIGH COUNTRY ESTATES SUBDIVISION ON FILE AS ENTRY NUMBER 172640 IN THE UINTAH COUNTY RECORDERS OFFICE; THENCE NORTH 01'53'35" WEST 565.56 FEET ALONG SAID LINE TO THE POINT OF BEGINNING. CONTAINING 69.16 ACRES MORE OR LESS.

3. The zoning map of Naples Utah shall be amended to include the real property described above in Paragraph 2.


