ORDINANCE NO. #2008-08ASATCH COUNTY CORPORATION

AN ORDINANCE ANNEXING PROPERTY KNOWN AS THE ANDERSON ANNEXATION LOCATED AT APPROXIMATELY MILL ROAD AND 1050 NORTH, HEBER CITY, WASATCH COUNTY, STATE OF UTAH.

BE IT ORDAINED BY THE CITY COUNCIL OF HEBER CITY, UTAH:

**Section 1.** That the 14.05 acres, described in the attached Exhibit A of this Ordinance is hereby assigned to and made a part of the R-1 Residential Zone, consistent with the Heber City General Plan, County of Wasatch, State of Utah.

Section 2. This Ordinance shall take effect and be in force from and after (a) its adoption, (b) a copy has been deposited in the office of the City Recorder, (c) a short summary of it has been published in the Wasatch Wave or a complete copy has been posted in three public places within Heber City, (d) the execution and recording of an Annexation Agreement and Covenant Running With the Land in substantially the form attached hereto as Exhibit B, and (e) the respective changes have been properly noted and attested to in the official zone map as required per Section 18.20.010 of the Heber City Municipal Code.

## Anderson Annexation Boundary Description

Beginning at the Wasatch County Survey Monument for the Southeast Corner of Section 29, Township 3 South, Range 5 East, Salt Lake Base and Meridian; and running thence South 901.66 feet to a point on the present city boundary of Heber City and evidenced by the Brown Annexation (see entry number 200282 of official records); thence West 193.25 feet along said Brown Annexation to a point on the present city boundary of Heber City as evidenced by the Valley Hills Estates Plat C Annexation (see entry number 113547 of official records); thence along the present city boundary of Heber City as evidenced by said Valley Hill Estates Plat C Annexation and the Valley Hills Estates Plat D Annexation (see entry number 113548 of official records) the following three (3) courses: (1) thence North 901.66 feet; (2) thence West 136.75 feet; (3) thence North 00°27'53" West 1323.84 feet to a point on the southerly boundary of Buckwheat Subdivision (see entry number 220600 of official records); thence South 89°37'00" East 336.61 feet along said southerly boundary; thence South 00°10'45" East 1321.55 feet along the westerly boundary of Wasatch View Acres Subdivision to the point of beginning.
