Re: Charleston Water Concervancy District Notice of Impending Boundary Action

Dear Lt. Governor:

My office represents the Charleston Water Conservancy District ("CWCD"), located in Wasatch County. The purpose of this letter is to comply with Utah Code Ann. § 67-1a-6.5, in giving notice of an impending boundary action.

CWCD is a duly organized District under Utah Code Annotated Title 17B et. al., with the purpose of providing culinary water to the citizens of the Town of Charleston. CWCD has proposed and approved annexation of the areas set forth in red on the map attached as Exhibit A to become a part of its service area.

As set forth below, Paul Winterton, President of CWCD does hereby verify and certify that the following applicable requirements were all met in approving the annexation:

- 1. On September 12, 2012, in accordance with Utah Code Ann. § 17B-1-403(1)(c), the CWCD board passed a resolution proposing to annex the areas set forth in red in Exhibit A to its service area. *See* Resolution attached as Exhibit B.
- 2. In accordance with Utah Code Ann. § 17B-1-406 notices were sent to the Town of Charleston, the Town of Daniel, and Wasatch County. None of the entities objected to the proposed annexation.
- 3. In accordance with Utah Code Ann. § 17B-1-410 notice of a public hearing was sent to all property owners within the proposed areas of annexation on November 30, 2012, and the notice was posted in four conspicuous places within each proposed area of annexation.

- 4. In accordance with Utah Code Ann. § 17B-1-409 a public hearing was held on December 13, 2012, at 7:00 p.m. The proceeding was recorded. The Board explained the annexation, and the two citizens who came to the hearing asked questions and received answer, upon which the hearing was adjourned.
- 5. In accordance with Utah Code Ann. § 17B-1-412 no protest was filed to the annexation.
- 6. In accordance with Utah Code Ann. § 17B-1-412, the Board met on February 11, 2013 and approved the formal annexation by passing the resolution attached as Exhibit C.
- 7. A formal plat map has been submitted, reviewed and signed by Wasatch County and the District.

As such, CWCD asks that your office formally recognize the annexation and adjust the boundaries of the District to match those set forth in the formal plat map attached hereto.


