ORDINANCE NO. 13-1 (1-15-13)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SARATOGA SPRINGS, UTAH ADJUSTING ITS COMMON BOUNDARIES WITH LEHI CITY, UTAH; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Utah Code § 10-2-419 establishes the procedure for adjusting the common boundaries between adjacent municipalities; and

WHEREAS, the City of Saratoga Springs, Utah shares common boundaries with Lehi City, Utah; and

WHEREAS, a portion of the roadway along SR-73 as well as 400 East ("Parcel") are located within Lehi City's boundaries, both of which are peninsulas within the municipal boundaries of the City of Saratoga Springs; and

WHEREAS, the City of Saratoga Springs and Lehi City desire to adjust their municipal boundaries as provided by State law by adding the Parcel to the municipal boundaries of the City of Saratoga Springs; and

WHEREAS, the City of Saratoga Springs has prepared a legal description and Boundary Line Adjustment plat that more fully describes the Parcel, which legal description and plat are attached as Exhibit A.

NOW THEREFORE, the City Council of the City of Saratoga Springs ordains as follows:

SECTION I – ENACTMENT

The City Council, in accordance with Utah Code § 10-2-419, adjusts its common boundaries with Lehi City. The City Council finds that the boundary adjustment promotes the health, safety, and welfare of the residents of the City of Saratoga Springs. A legal description and map showing the location of the adjustment area are attached as Exhibit A to this Ordinance. No protests were received to this action.

SECTION II – REPEALER

If any provisions of the Saratoga Springs Code are inconsistent with this ordinance they are hereby repealed.

SECTION III – AMENDMENT OF CONFLICTING ORDINANCES

To the extent that any ordinances, resolutions, or policies of the City of Saratoga Springs conflict with the provisions of this ordinance, they are hereby amended to comply with this ordinance.

SECTION IV – EFFECTIVE DATE

This ordinance shall take effect following publication of a short summary of the ordinance in the Provo Daily Herald on one occasion as required by Utah Code § 10-3-711 and following the proper filing, recording, and notice required in Utah Code § 10-2-425.

SECTION V – SEVERABILITY

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this ordinance.

SECTION VI – PUBLIC NOTICE

The Saratoga Springs Recorder is hereby ordered, in accordance with the requirements of Utah Code §§ 10-3-710—711, to do as follows:

- a. deposit a copy of this ordinance in the office of the City Recorder; and
- b. publish notice as follows:
 - i. publish a short summary of this ordinance for at least one publication in a newspaper of general circulation in the City; or
 - ii. post a complete copy of this ordinance in three public places within the City.

A Parcel being located within the Northeast quarter of Section 14, and the Northwest quarter of section 13, Township 5 South, Range 1 West, Salt Lake Base and Meridian.

Beginning at a point on the Northerly right of way of SR 73, said point being located East 324.80 feet and South 1322.15 feet more or less from the Northwest corner of Section 13, said Township and Range, (Basis of bearing is the north line of the Northeast quarter of section 14 bearing of North 89°51'44" East)

And running thence South 7°56'30" West 201.00 feet more or less to the Southerly Right of Way line of SR 73; Thence North 89°24'04" West a distance of 333.66 feet along said Southerly Right Of Way to the Easterly Right of way line of 10420 West street;

Thence South 17°32'06" West a distance of 102.46 feet along said right of way line of 10420 West Street;

Thence South 88°42'14" West a distance of 46.66 feet to the Westerly Right Of Way line of 10420 West Street, Said point also being on the Easterly Line of Boundary line adjustment between Saratoga Springs and Lehi City per Document recorded in Entry number 119775-2009 and following along said adjustment line the following 3 courses;

Thence North 04°34'00" West 304.43 feet along said road;

Thence North 08°48'00" West 220.96 feet along the West side of 3600 West Street; Thence East 28.84 feet more or less to the East line of Road, Said point also being on a fence line and the arc of a 2,200 foot radius curve to the right; Thence continuing Southerly

along said curve and fence for a distance of 512.00 feet (chord bearing South 8°18'00" East 511.3 feet);

Thence continuing along said fence line on the Easterly side of County road South 01°18'00" East 172.3 feet;

Thence continuing along said fence line and Easterly side of County road South 01°18'00" East 538.7 feet to a fence line;

Thence South 23°20'00" East along said fence line and line per parcel 6 as referenced in document recorded in entry # 14906:2004 for 109.3 feet to a fence line and on the Northerly side

ORDINANCE NO. 05-2013

AN ORDINANCE OF THE LEHI CITY COUNCIL EXPRESSING THE INTENT TO ADJUST ITS COMMON BOUNDARIES WITH SARATOGA SPRINGS, UTAH; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Utah Code § 10-2-419 establishes the procedure for adjustment of the common boundaries between adjacent municipalities; and

WHEREAS the City of Saratoga Springs, Utah shares certain common boundaries with Lehi City, Utah; and

WHEREAS, the City of Saratoga Springs and Lehi City have determined that that a portion of the roadway along SR-73 as well as 400 East are located within Lehi City's boundaries, both of which are peninsulas within the municipal boundaries of the City of Saratoga Springs; and

WHEREAS, the City of Saratoga Springs and Lehi City desire to adjust their municipal boundaries as provided by State law by adding the Parcel to the municipal boundaries of the City of Saratoga Springs; and

WHEREAS, the City of Saratoga Springs has prepared a Boundary Line Adjustment plat that more fully describes the Parcel, which plat is attached as Exhibit A.

NOW, THEREFORE, IT IS ORDAINED BY THE CITY COUNCIL OF LEHI CITY, UTAH, AS FOLLOWS:

- Section 1. The City Council, in accordance with Utah Code 10-2-419, adjusts its common boundaries with the City of Saratoga Springs. The City Council finds that the boundary adjustment promotes the health, safety, and welfare of the residents of Lehi City. A legal description and map showing the location of the adjustment area are attached as Exhibit A to this ordinance. No protests were received to this action.
- <u>Section 2.</u> The area as specifically described in the Boundary Adjustment Plat is hereby removed from Lehi City, subject to compliance with the terms and provisions of Utah Code 10-2-419.
- Section 3. The City Recorder is hereby directed to file the transparent reproducible Boundary Adjustment Plat, together with a certified copy of this ordinance in the office of the Utah County Recorder when all Provisions of Utah Code 10-2-419 have been complied with which are conditions precedent to the recordation.
- Section 4. This ordinance shall become effective following subsequent publication as provided by law.

Thence North 0°00'00" East a distance of 128.35 feet to the Wathen Addition per document Entry number 83577-2003;

Thence along said line North 89°28'02" East a distance of 551.03 feet more or less to the Southwest corner of the boundary line adjustment between Saratoga Springs and Lehi City per the document recorded in Entry number 14906-2004;

Thence along boundary line North 89°28'00" East 655.10 more or less to Southeast corner of property (parcel #5 per document) as described in the below referenced document (Entry number 14906-2004) Thence along said boundary line as follows;

North 00°30'00" West 335.8 feet; Thence North 00°30'00" West 283.7 feet to the Southeast corner of property as described in the boundary line adjustment between Saratoga Springs and Lehi City in Document as recorded in Entry number 142902-2006 said point being on the West side of road and at a fence corner; Thence North 01°31'00" West 175.80 feet;

Thence North 04°34'00" West 304.43 feet along said road;

Thence North 08°48'00" West 220.96 feet along the West side of 3600 West Street; Thence East 28.84 feet more or less to the East line of Road, Said point also being on a fence line and the arc of a 2,200 foot radius curve to the right; Thence continuing Southerly

along said curve and fence for a distance of 512.00 feet (chord bearing South 8°18'00" East 511.3 feet);

Thence continuing along said fence line on the Easterly side of County road South 01°18'00" East 172.3 feet;

Thence continuing along said fence line and Easterly side of County road South 01°18'00" East 538.7 feet to a fence line;

Thence South 23°20'00" East along said fence line and line per parcel 6 as referenced in document recorded in entry # 14906:2004 for 109.3 feet to a fence line and on the Northerly

side of Utah State Highway; Thence South 89°12'00" East Along said line per document referenced above for 360.3 feet more or less to the point of beginning.
