ORDINANCE NO. 01-15-2020 A

AN ORDINANCE EXTENDING THE MUNICIPAL BOUNDARIES OF PAYSON, UTAH TO INCLUDE PARCELS INCLUDED IN THE RIDING ANNEXATION, AND PROVIDING AN EFFECTIVE DATE.

Preamble

WHEREAS, the Payson City Council accepted a petition for the Riding Annexation for further review on November 6, 2019, pursuant to Section 10-2-403, et. seq. Utah Code Annotated 1953, as amended, and the petition satisfied the requirements of the above-stated section; and,

WHEREAS, the petition was certified by the Payson City Recorder on November 8, 2019, and a notice was published and mailed pursuant to the requirements of Section 10-2-406, Utah Code Annotated 1953, as amended; and,

WHEREAS, no qualified protests were filed with Payson City or Utah County pursuant to Section 10-2-407, Utah Code Annotated 1953, as amended; and,

WHEREAS, a public hearing was held on January 15, 2020, pursuant to Utah Code Annotated, 1953, as amended; and,

WHEREAS, the petition includes property in the unincorporated area of Utah County that is contiguous to Payson, and all the requirements of the Utah Code in relation to annexation have been satisfied; and,

WHEREAS, the Payson City Council determines the annexation is a logical extension of the municipal boundaries and will further the goals of the Payson City General Plan;

NOW THEREFORE, be it ordained by the City Council of Payson, Utah, that the parcels included in the Riding Annexation be annexed into the corporate boundaries of Payson City. The annexed area is more fully described as follows:

BEGINNING AT A POINT BEING N.89°34'59" E. 1219.75' ALONG THE SECTION LINE AND SOUTH 522.85' FROM THE NORTHWEST CORNER OF SECTION 29, TOWNSHIP 9 SOUTH, RANGE 2 EAST, SALT LAKE BASE & MERIDIAN; THENCE, N 89° 00' 01" E FOR A DISTANCE OF 1402.06 FEET TO A POINT ON A LINE, SAID LINE BEING ALONG THE EXISTING PAYSON CITY BOUNDARY LINE. THENCE, ALONG THE PAYSON CITY BOUNDARY LINE, S 02° 18' 00" W FOR A DISTANCE OF 51.09 FEET TO A POINT ON A LINE. THENCE, S 88° 51' 08" W FOR A DISTANCE OF 618.97 FEET TO A POINT ON A LINE. THENCE, S 88° 36' 40" W FOR A DISTANCE OF 268.26 FEET TO A POINT ON A LINE. THENCE, S 88° 08' 15" W FOR A DISTANCE OF 387.10 FEET TO A POINT ON A LINE. THENCE, S 89° 53' 29" W FOR A DISTANCE OF 138.64 FEET TO A POINT ON A LINE. THENCE N 12° 21' 00" E A DISTANCE OF 59.71 FEET TO THE POINT OF BEGINNING. CONTAINS 1.76 ACRES. PROJECT BASED ON STATE PLANE COORDINATES, NAD83

This Ordinance shall take effect immediately upon passage by the City Council and subsequent publication in the Payson Chronicle having general circulation in Payson City.
