RESOLUTION APPROVING THE DISSOLUTION OF THE UTAH VALLEY DISPATCH SPECIAL SERVICE DISTRICT

WHEREAS, the Utah Valley Dispatch Special Service District ("District") was created by resolution of the Board of County Commissioners of Utah County on the 30th day of September, 2008 to provide public safety dispatch services to Utah County and all of the cities therein except for Pleasant Grove, Lindon, Orem, Provo, Springville, and Mapleton; and

WHEREAS, Juab County and Nephi City applied for membership to the District; and

WHEREAS, Utah law does not provide for an easy method to organize multi-county service districts, except for water conservation districts; and

WHEREAS, the adding of Juab County and Nephi City brings benefit to members of the District by their telecommunications equipment and having greater economies of scale; and

WHEREAS, in order to receive the benefits of adding Juab County and Nephi City, an interlocal entity was created known as Central Utah 911 by all of the members of the District, Juab County, and Nephi City; and

WHEREAS, all of the functions, obligations, and assets of the District have been previously transferred to Central Utah 911 and Juab County and Nephi City have also previously contributed assets to Central Utah 911; and

WHEREAS, pursuant to the provisions of Utah Code Ann. §§17D-1-601 and 602, a special service district may be dissolved by resolution of the legislative body of the county that created the district if there are no outstanding bonds, notes, or other obligations, and if there are no contractual obligations to provide service; and

WHEREAS, the District has no outstanding bonds, notes, or other obligations; and

WHEREAS, the District has no existing contractual obligations to provide services;

WHEREAS, the Utah State Retirement System has moved all of the employees of the District over to be employees of Central Utah 911; and

WHEREAS, the IRS and Utah State Tax Commission have issued tax ID numbers to Central Utah 911 so all employment related taxes are being paid by Central Utah 911; and

WHEREAS, Central Utah 911 is now providing public safety dispatch services to all member of the District; and

WHEREAS, the District is no longer needed for the purposes for which it was created;

NOW THEREFORE, be it resolved by the Board of Commissioners of Utah County as follows:

- That the Board of Commissioners of Utah County finds that it can approve the dissolution of the District.
- That the Board of Commissioners of Utah County finds that the District is no longer needed for the purposes for which it was created.
- That the Board of Commissioners of Utah County hereby approves the dissolution of the District, pursuant to Utah Code Ann. §17D-1-601(2).
- 4. That the Board of Commissioners of Utah County hereby directs staff that within 30 days after adopting this resolution, to file with the lieutenant governor copy of a notice of an impending boundary action, as defined in Utah Code Ann. §67-1a-6.5, that meets the requirements of Utah Code Ann. §67-1a-6.5(3).
- 5. That upon the lieutenant governor's issuance of a certificate of dissolution under Utah Code Ann. §67-1a-6.5, the Board of Commissioners of Utah County further directs staff to submit to the Utah County Recorder's Office the following documents to be recorded:
 - a. the original notice of an impending boundary action;
 - b. the original certificate of dissolution; and
 - c. a certified copy of this resolution approving the dissolution of the District.
- That upon the lieutenant governor's issuance of the certificate of dissolution under Utah
 Code Ann. §67-1a-6.5, the District is dissolved.
