

RESOLUTION 2007- 15

A Resolution Establishing the Annexation of territory contiguous to the City of Blanding.

WHEREAS, a majority of the owners of real property and the owners of not less than one-third in value of the real property as shown on the last assessment rolls in territory contiguous to the City of Blanding have petitioned said City for annexation; and

WHEREAS, the petition was accompanied by an accurate plat or map of the territory to be annexed prepared under the supervision of a competent engineer or land surveyor certified by the same; and

WHEREAS, the petition and plat or map have been filed in the office of the City Recorder;

NOW BE IT THEREFORE, RESOLVED by the City Council of the City of Blanding, Utah:

Section 1. Territory annexed. The territory described below is hereby declared annexed to the City of Blanding:

Beginning at the ¼ Corner common to Sections 27 and 34, Township 36 South, Range 22 East, Salt Lake Base and Meridian and running thence S01°11'05"E 706.24 feet along the North-South Center Section line of said Section 34; thence leaving said Section line S88°48'55"W 270.00 feet; thence S01°11'05"E 210 feet; thence N88°48'55"E 270.00 feet to the North-South Center Section line of said Section 34; thence along said Center Section line S01°11'05"E 62.09 feet; thence leaving said Center Section line S88°45'59"W 454.23 feet; thence S01°14'56"E 168.96 feet; thence S88°44'09"W 627.20 feet; thence S01°14'56"E 170.44 feet to the 1/16 line; thence along the 1/16 line S88°59'04"W 238.67 feet to the Northwest 1/16 corner of said Section 34; thence N01°13'56"W 1318.07 feet along the 1/16 line to the West 1/16 Corner common to Sections 27 and 34; thence N01°18'30"W 339.00 feet along the 1/16 line; thence N88°48'24"E 1321.51 feet to the North-South Center Section line of Section 27; thence S01°11'23"E 339.00 feet along said Center Section line to the point of beginning. 
