ORDINANCE A01-08

AN ORDINANCE ANNEXING PROPERTY KNOWN AS THE ENVISION ANNEXATION

WHEREAS, a petition has been filed with the Spanish Fork City Council by the majority of the owners representing over 1/3 of the assessed valuation of real property hereinafter described, which property lies contiguous to the corporate limits of Spanish Fork City; and

WHEREAS, the petitioners have also submitted an accurate plat of said territory and have filed the same in the office of the Spanish Fork City Recorder; and

WHEREAS, the Spanish Fork City Recorder has certified that the petition complies with the requirements of Utah Code Annotated §10-2-402 (1953 as amended), as they pertain to the annexation; and

WHEREAS, Spanish Fork City has accepted the petition and certified it to the Utah County Boundary Commission pursuant to Utah Code Ann. §10-2-405 on the 4th day of May, 2007, and

WHEREAS, publication of the certification took place in the Daily Herald, a paper with local circulation in Spanish Fork City on the days of May 14th, 21s, and 28th, 2007; and

WHEREAS, Spanish Fork City has studied the impact this annexation would have on the City, including utility impact fees, infrastructure, and transportation; and

WHEREAS, no protests were received concerning the annexation petition; and

WHEREAS, a public hearing was held before the Spanish Fork City Council on the 5th day of February, 2008, pursuant to Utah Code Ann. §10-2-407 with notice having taken place in accordance with said section; and

WHEREAS, at the public hearing no objection to the annexation was voiced; and WHEREAS, the property petitioned for annexation lies contiguous to rural residential zones in Spanish Fork City and is undeveloped.

SECTION I.

The boundaries of Spanish Fork City are hereby extended so as to include and incorporate within the said City limits the following described real property located in Utah County, Utah:

BEGINNING AT A POINT WHICH IS NORTH 00^10'48" EAST ALONG THE SECTION LINE 1354.67 FEET AND EAST 1288.75 FEET FROM THE SOUTHWEST CORNER OF SECTION 21, TOWNSHIP 8 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN; THENCE EAST 1364.33 FEET; THENCE NORTH 89^42'05" EAST 776.65 FEET; THENCE SOUTH 28^12'38" EAST 733.34 FEET; THENCE EAST 214.62 FEET; THENCE SOUTH 660.00 FEET; THENCE SOUTH 23^55'51" WEST 26.72 FEET; THENCE WEST 210.57 FEET; THENCE SOUTH 00^23'00" WEST 15.71 FEET; THENCE NORTH 89^52'02" WEST 589.91 FEET; THENCE SOUTH 00^12'25" EAST 14.21 FEET; THENCE SOUTH 89^44'45" WEST ALONG THE EXISTING SPANISH FORK CITY BOUNDARY AND ITS LINE EXTENDED 1885.84 FEET; THENCE ALONG SAID EXISTING CITY BOUNDARY NORTH 00^12'44" WEST

1363.54 FEET TO THE POINT OF BEGINNING. AREA = 78.172 ACRES (3405183.07 SQ. FT.)

SECTION II.

The following parcel is hereby zoned as R-R.

BEGINNING AT A POINT WHICH IS NORTH 00^10'48" EAST ALONG THE SECTION LINE 1354.67 FEET AND EAST 1288.75 FEET FROM THE SOUTHWEST CORNER OF SECTION 21, TOWNSHIP 8 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN; THENCE EAST 1364.33 FEET; THENCE NORTH 89^42'05" EAST 3.39 FEET; THENCE SOUTH 1357.51 FEET; THENCE SOUTH 89^44'45" WEST ALONG THE EXISTING SPANISH FORK CITY BOUNDARY AND ITS LINE EXTENDED 1362.68 FEET; THENCE ALONG SAID EXISTING CITY BOUNDARY NORTH 00^12'44" WEST 1363.54 FEET TO THE POINT OF BEGINNING.

AREA = 42.639 ACRES (1857365.92 SQ. FT.)

SECTION III

The following parcel is hereby zoned as R-1-15:

BEGINNING AT A POINT WHICH IS NORTH 00^10'48" EAST ALONG THE SECTION LINE 1354.69 FEET AND EAST 2656.47 FEET FROM THE SOUTHWEST CORNER OF SECTION 21, TOWNSHIP 8 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN; THENCE NORTH 89^42'05" EAST 773.26 FEET; THENCE SOUTH 28^12'38" EAST 733.34 FEET; THENCE EAST 214.62 FEET; THENCE SOUTH 660.00 FEET; THENCE SOUTH 23^55'51" WEST 26.72 FEET; THENCE WEST 210.57 FEET; THENCE SOUTH 00^23'00" WEST 15.71 FEET; THENCE NORTH 89^52'02" WEST 589.91 FEET; THENCE SOUTH 00^12'25" EAST 14.21 FEET; THENCE SOUTH 89^44'45" WEST ALONG THE EXISTING SPANISH FORK CITY BOUNDARY AND ITS LINE EXTENDED 523.16 FEET; THENCE NORTH 1357.51 FEET TO THE POINT OF BEGINNING.

AREA = 35.533 ACRES (1547817.16 SQ. FT.)

SECTION IV

An annexation agreement was entered into on the 27th day of May, 2008.

SECTION V

The annexation is conditional upon the following:

1. That the SESD power buyout be completed before recordation.

SECTION VI

This Ordinance shall not become part of the Spanish Fork City Municipal Code.

SECTION VII

This Ordinance shall become effective immediately upon publication.
