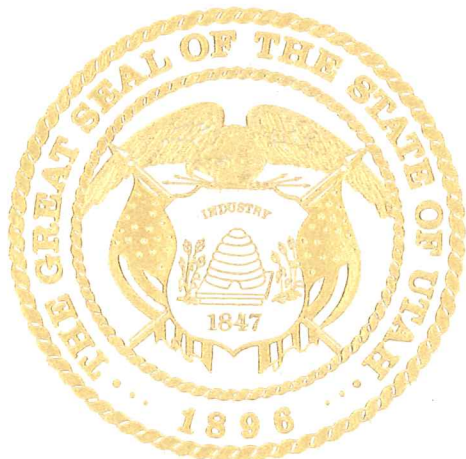

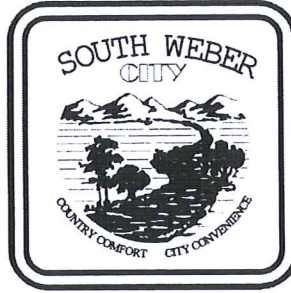



# ORDINANCE 09-01

## AN ORDINANCE CREATING COMMUNITY REDEVELOPMENT AND RENEWAL AGENCY ("RDA") FOR SOUTH WEBER CITY, UTAH

**WHEREAS**, it has been determined by the South Weber City Council that it is in the best interest of the City to establish a Community Development and Renewal Agency; and

**WHEREAS**, a Community Development and Renewal Agency is created to undertake or promote urban renewal, economic development, or community development, or any combination of them; and


**WHEREAS**, the governing body of Community Development and Renewal Agency is a board consisting of the current members of the legislative body of the community that created the agency.

**NOW, THEREFORE, BE IT ORDAINED** that the City Council of South Weber City, Davis County, Utah, establishes a Community Development and Renewal Agency, herein after "Redevelopment Agency," "Agency" or "RDA" and designates the members of the City Council as the "RDA" board of the city, and shall have all the powers and duties as are specified in the applicable sections of the Utah Code Annotated relating to the same.

**EFFECTIVE DATE:** This ordinance shall take effect immediately upon posting.

**PASSED AND ADOPTED** by the City Council of South Weber City, South Weber, Davis County, Utah, this 27<sup>th</sup> day of January, 2009.
