

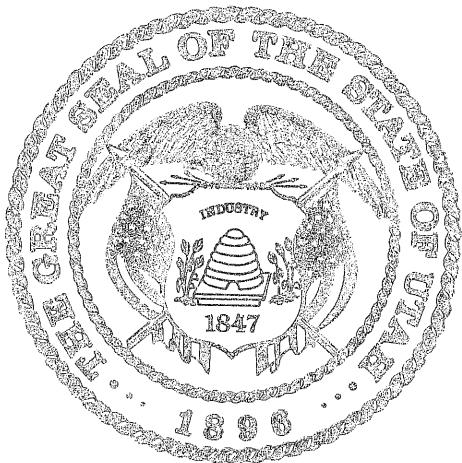

ORDINANCE NO. 11-001

AN ORDINANCE DISCONNECTION (DEANNEXATION) OF CERTAIN PROPERTIES OUTSIDE OF THE TOWN OF CORNISH, UTAH, (S. HILTON DISCONNECTION).

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF CORNISH, UTAH:

PART I

- Section 1.** That certain territory as described on the disconnection Exhibit A and Survey Plat, referred to as the Samuel W. Hilton disconnection, is hereby disconnected from the town of Cornish, Utah.
- Section 2.** The corporate limits of the Town of Cornish are hereby shortened by the said described territory.

PART II

This Ordinance shall take effect on its passage and posting as required by law.


