



ORDINANCE #03-16-11-1  
ANNEXATION

An ordinance declaring annexation of territory and extension of corporate limits of Manti City.

WHEREAS, a petition for annexation has been received by Manti City from the owner of real property requesting annexation to Manti City and . . .

WHEREAS, Manti City has certified this petition in that it meets the criteria as defined in the annexation policy plan of Manti City and the City recognizes the need to extend the corporate limits of Manti City . . .

NOW THEREFORE, be it ordained by the City Council of Manti City, Sanpete County, Utah:

SECTION I.

IT is hereby declared that the following real property is annexed into the corporate limits of Manti City and the corporate limits of Manti City are extended accordingly. Said property is located Sanpete County, State of Utah and is more particularly described as follows . . .

BEG PT LOCATED N 1801.30 FT. E 299.45 FT FROM CENTER SEC 7-18-3E, PT BEING LOCATED ON AN EXISTING FENCE CORNER, N 00°30'16"W ALONG SAID FENCE LINE 106.11 FT TO PT ON N LINE TAX PAR 7346, S 88°19'20"E ALONG N LINE SAID TAX PAR AND LEAVING SAID FENCE LINE 217.35 FT, S 00°57'15"E 93.81 FT, S 88°26'13"W 21.97 FT TO PT OF BEG.
