MINERSVILLE TOWN, A Municipal Corporation ORDINANCE NO. 03-06-12-1

AN ORDINANCE DECLARING THE ANNEXATION OF TERRITORY TO THE TOWN OF MINERSVILLE.

WHEREAS, a majority of the owners of real property and the owners of not less than one-half in value of the real property as shown on the last assessment rolls in territory by and contiguous to this municipality have petitioned this municipality for annexation; and,

WHEREAS, the Annexation Petition was accompanied by an accurate plat or map of the territory to be annexed, prepared under the supervision of the City Engineer or a competent surveyor and certified by the engineer or surveyor; and,

WHEREAS, the petition and plat or map have been filed in the office of the Minersville Town Clerk and all other requirements for annexation having been met;

NOW THEREFORE, IT IS HEREBY ORDAINED by the Town Council of Minersville
Town:

Section 1. TERRITORY ANNEXED. The territory located in Beaver County, State of Utah and described below and in the Petition for Annexation of Property and the Minersville, Utah Annexation Map-Northwest Addition is hereby declared annexed to the municipality:
