ORDINANCE NO. 2008-02

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF SOUTH JORDAN CITY, UTAH, TO INCLUDE THE AREA DESCRIBED IN EXHIBIT "A" AND AMENDING THE SOUTH JORDAN CITY ZONING MAP TO DESIGNATE AND ZONE THE ANNEXED AREA AS R-4 UPON ITS ANNEXATION TO THE CITY.

WHEREAS, South Jordan City received petitions (hereinafter "Petition.") submitted by Beth W. Koch, Gary M. Anderson, and Sandra L. Anderson as property owners, requesting the annexation of unincorporated territory in Salt Lake County, Utah, into South Jordan City, Utah; and

WHEREAS, The Petition is signed by a majority of the owners of real property and the owners of more than one-third in value of all real property within the area to be annexed as shown by the last assessment rolls of Salt Lake County; and

WHEREAS, the petitioners have caused an accurate plat to be made and certified by a licensed engineer or a licensed surveyor to be approved by the City prior to the filing; and

WHEREAS, the City prepared and provided a Specific Annexation Policy Declaration and mailed the same to all affected entities as required by law; and

WHEREAS, the South Jordan City Council, after examining said petition, having the petition reviewed by its administrative staff, and having noticed and held a hearing on the 20th of November, 2007, and after finding said proposed annexation and specific annexation policy declaration to be consistent and in keeping with the city's Master Annexation Policy Declaration projecting municipal expansion;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF SOUTH JORDAN, STATE OF UTAH:

Section 1. Annexation. The South Jordan City limits are hereby enlarged and extended so as to include the property which is the subject of the petition for annexation filed by Beth W. Koch, Gary M. Anderson, and Sandra L. Anderson including approximately 5.114 acres of unincorporated territory in Salt Lake County, State of Utah, which property extends the existing City corporate limits. Said property is more particularly described in Exhibit "A", attached to this Ordinance and incorporated herein as though fully set forth.

<u>Section 2.</u> <u>Zoning.</u> The annexed property is hereby initially designated and zoned R-4 and the South Jordan City Land Use and Zoning Maps is hereby correspondingly amended.

Section 3. General Jurisdiction. The property described herein shall henceforth be within the South Jordan City corporate limits and shall be zoned as provided in Section 2. All ordinances, jurisdictions, rules, and obligations of or pertaining to South Jordan City are extended over and applicable and pertinent to the above-described tract of land; and the streets, blocks, and right-of ways of said tract shall be controlled and governed by the Ordinances, rules and regulations of South Jordan City.

<u>Section 4.</u> <u>Effective Date.</u> This Ordinance shall become effective immediately upon publication or posting, or thirty (30) days after final passage by the City Council, whichever occurs first.
