
CERTIFICATE OF ANNEXATION

The Mountain Green Sewer Improvement District is filing this notice of annexation in accordance with Title 17B-2-514(2)(a).

This annexation involves only one lot, the home of William and Julie Quinn, which is lot number sixty two in the Rosehill Subdivision Number One in Morgan County (4229 Iris Avenue). Property Tax serial number 02-RH3-0062. Mr. And Mrs. Quinn petitioned the District for annexation in a petition dated May 03, 2013, a copy of which is attached. Also attached is a copy of the warranty deed to the property, obtained from the Morgan County Recorder's office, which deed provides a legal description of the area to be annexed. 


