

RESOLUTION OF ANNEXING
OF REAL PROPERTY

WHEREAS, The owner and total tax payer of all the private real property in all of Serial No. 19-320-0001, 19-320-0002, 19-320-0003 private property in Weber County, Utah filed a petition to have that area annexed into Bona Vista Water Improvement District to secure culinary water service from that District and,

WHEREAS, That District certified that petition was proper and complete and gave notice of intent to annex that area as required by law and fixed the District's regular meeting at its office 2020 West 1300 North in Farr West at 2:00 p.m. Monday, April 28, 2014 as the time and place for the consideration and action on that petition.


2. The area annexed is shown on the attached plat which is a part of this Resolution and is described as follows:

Part of the Northwest quarter of Section 21, Township 7 North, Range 2 West, Salt Lake Base and Meridian; Beginning at a point on the North right of way line of 3600 North Street being South 0°50'50" West 2637.23 feet and North 89°42'28" West 1122.00 feet from the North Quarter corner of said Section 21, and running thence North 88°54'20" West 250.00 feet to the existing boundary line of the Bona Vista Water Improvement District, thence then along said boundary line the following two courses; North 0°50'51" East 871.00 feet and North 88°54'20" West 300.00 feet, thence North 0°50'50" East 119.00 feet, thence South 88°54'20" East 352.00 feet, thence North 0°50'50" East 330.00 feet, thence South 88°54'20" East 198.00 feet to the existing boundary line of the Bona Vista Water Improvement District, thence along said boundary South 0°50'50" West 1290.00 feet to the point of beginning.






Certification of Filing Notice of Annexation


