
The name of the local entity whose boundary is affected by the boundary action is the “North Pointe Solid Waste Special Service District.”





The Board of County Commissioners (the "Board") of Utah County, Utah, met in regular public session at its regular meeting place of the Board in Provo, Utah, on Tuesday, October 28, 2014, at 9:00 a.m. The meeting was called to order by the Chair of the Board with the following being present, and constituting a quorum:

After the meeting had been duly called to order and after other matters not pertinent to this Resolution had been discussed, a Certificate of Compliance with Open Meeting Law with respect to this October 28, 2014, meeting was presented to the Board, a copy of which is attached hereto as Exhibit A.

The Resolution was then signed by the Chair in open meeting and recorded by the Clerk/Auditor in the official records of Utah County, Utah. The Resolution is as follows:

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF UTAH COUNTY, UTAH, APPROVING THE WITHDRAWAL OF THE REAL PROPERTY CONTAINED WITHIN THE CORPORATE LIMITS OF ALPINE CITY, EAGLE MOUNTAIN CITY, THE TOWN OF CEDAR FORT, AND THE TOWN OF FAIRFIELD FROM THE NORTH POINTE SOLID WASTE SPECIAL SERVICE DISTRICT BOUNDARIES; AND RELATED MATTERS.

WHEREAS, the North Pointe Solid Waste Special Service District (the "District") (previously named the Utah County Solid Waste Special Service District) was established by the Board of County Commissioners (the "Board") of Utah County, Utah (the "County") pursuant to Resolution 1976-61, adopted by the Board on December 17, 1976 (the "Establishing Resolution"); and

WHEREAS, pursuant to Section 17D-1-601, Utah Code Annotated 1953, as amended ("UCA") the County may, by resolution, approve the withdrawal of an area from the District, if the Board determines that the area to be withdrawn should not or cannot be provided the service that the District provides; and

WHEREAS, the Establishing Resolution included as the boundaries of the District all of Utah County, except for the corporate boundaries of Provo City, Payson City, the Town of Santaquin, the Town of Goshen, and the Town of Genola; and

WHEREAS, pursuant to Resolution 1984-31, adopted by the Board on December 10, 1984, the Board approved the withdrawal of the area contained within the corporate boundaries of Springville City, Spanish Fork City, Salem City, the Town of Elk Ridge, and the Town of Woodland Hills, from the boundaries of the District; and

WHEREAS, Alpine City, Eagle Mountain City, the Town of Cedar Fort, and the Town of Fairfield (collectively the "Withdrawing Cities") have elected to discontinue their use of the services provided by the District; and

WHEREAS, the Board finds that it is in the best interest of the District to withdraw the area contained within the corporate boundaries of the Withdrawing Cities (the "Withdrawn Areas") from the boundaries of the District; and

WHEREAS, the Board finds that the Withdrawn Areas should not be provided the services provided by the District based upon the election of the Withdrawing Cities to discontinue their use of the services provided by the District; and

WHEREAS, the Board finds that the Withdrawn Areas cannot be provided the services provided by the District based upon the election of the Withdrawing Cities to discontinue their use of the services provided by the District; and

WHEREAS, pursuant to Section 17D-1-602(1)(a) , UCA, the Board finds that the District does not have any bond, note, or other obligation outstanding and unpaid, and further finds that there do not exist any contractual obligations of the District to provide District services to the Withdrawing Cities;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF UTAH COUNTY, UTAH AS FOLLOWS:

Section 1. All terms defined in the recitals hereto shall have the same meaning when used herein.

Section 2. The areas contained within the corporate boundaries of Alpine City, Eagle Mountain City, the Town of Cedar Fort, and the Town of Fairfield, are hereby approved to be withdrawn from the North Pointe Solid Waste Special Service District boundaries. The Withdrawn Areas are described in Exhibit B attached hereto. A copy of the approved final local entity plat showing the Withdrawn Areas and the new boundaries of the District is attached hereto as Exhibit C.

Section 3. The areas contained within the corporate boundaries of Alpine City, Eagle Mountain City, the Town of Cedar Fort, and the Town of Fairfield, are hereby withdrawn from the North Pointe Solid Waste Special Service District boundaries, with the withdrawal to be effective upon the Utah Lieutenant Governor's issuance of the Certificate of Withdrawal.

Section 4. Within 30 days after the adoption of this Resolution, a copy of an impending boundary action, as defined in Section 67-1a-6.5, UCA, in the form attached hereto as Exhibit D, and a copy of the approved final local entity plat, as defined in Section 67-1a-6.5, UCA, Exhibit C, shall be filed with the Utah Lieutenant Governor.

Section 5. The Board hereby approves the discontinuation of the services provided to property within the boundaries of the District to the Withdrawn Areas.

Section 6. Upon the Lieutenant Governor's issuance of a certificate of withdrawal the County shall submit to the Utah County Recorder (i) the original notice of an impending boundary action; (ii) the original certificate of withdrawal; (iii) the original approved final local entity plat; and (iv) a certified copy of this Resolution.

Section 7. The officers of the County are hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

Section 8. If any one or more sections, sentences, clauses, or parts of this Resolution shall, for any reason, be questioned or held invalid, such judgment shall not affect, impair, or invalidate the remaining provisions of this Resolution, but shall be confined in its operation to the specific sections, sentences, clauses, or parts of this Resolution so held unconstitutional and invalid, and the inapplicability and invalidity of any section, sentence, clause, or part of this Resolution in any one or more instances shall not affect or prejudice in any way the applicability and validity of this Resolution in any other instances.

Section 9. All resolutions of the County in conflict with this Resolution are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any Resolution, by-law or regulation, or part thereof, heretofore repealed.

Section 10. This Resolution shall take immediate effect upon its adoption and approval.


