

AN ORDINANCE

AN ORDINANCE AMENDING SECTION 1.12.010 OF THE REVISED ORDINANCES OF AMERICAN FORK CITY 1985, AS AMENDED, ANNEXING CERTAIN PROPERTIES TO AMERICAN FORK CITY AND ESTABLISHING ZONING CLASSIFICATION FOR SAID PROPERTY.

BE IT ORDAINED BY THE CITY COUNCIL OF AMERICAN FORK CITY, UTAH:

SECTION I. THAT THE FOLLOWING DESCRIBED REAL PROPERTY BE, AND THE SAME IS HEREBY ANNEXED TO AMERICAN FORK CITY, UTAH, THE CORPORATE LIMITS OF SAID CITY ARE HEREBY EXTENDED TO INCLUDE SAID DESCRIBED PROPERTY, AND SAID PROPERTY IS HEREBY DECLARED TO BE PART OF AMERICAN FORK CITY AND SHALL HENCEFORTH BE SUBJECT TO ALL OF THE ORDINANCES AND REGULATIONS THEREOF, AND THAT THE DESCRIPTION OF THE BOUNDARIES OF AMERICAN FORK CITY AS SET FORTH IN SECTION 1.12.010 OF THE REVISED ORDINANCES BE AMENDED TO INCLUDE THE FOLLOWING DESCRIBED PROPERTY TO-WIT:

ORDINANCE NO. 2015-12-75
HARBOR ENTERPRISES PLAT A ANNEXATION (600 WEST 500 SOUTH)
SEE ATTACHMENT 'A'

SECTION II. THAT THE TERRITORY ANNEXED UNDER SECTION I ABOVE, IS HEREBY CLASSIFIED INTO THE RA-5 RESIDENTIAL AGRICULTURAL ZONE AND SUBJECT TO THE TERMS AND CONDITIONS OF THE HARBOR ENTERPRISES PLAT A ANNEXATION AGREEMENT AS PROVIDED IN ATTACHMENT 'B'.

SECTION III. THIS ORDINANCE SHALL TAKE EFFECT UPON ITS PASSAGE AND FIRST PUBLICATION. PASSED BY THE CITY COUNCIL OF AMERICAN FORK, THIS 8 DAY OF DECEMBER, 2015.



RUNNING THENCE SOUTH 451.08 FEET, A PORTION OF WHICH LIES ALONG THE EXISTING AMERICAN FORK CITY BOUNDARY AS DEFINED BY THE EYRE ANNEXATION; THENCE S 89°41'10" W 7.05 FEET; THENCE S 01°01'46" W 1282.06 FEET; THENCE S 89°58'00" W 555.87 FEET; THENCE N 00°37'38" E 248.29 FEET; THENCE N 89°46'41" W 317.51 FEET; THENCE S 00°37'38" W 6.02 FEET; THENCE S 88°38'26" W 3.92 FEET; THENCE S 00°18'38" W 683.99 FEET; THENCE ALONG THE ARC OF A 833.00 FOOT RADIUS CURVE TO THE LEFT 106.15 FEET (CURVE HAS A CENTRAL ANGLE OF 07°18'05" AND A CHORD THAT BEARS S 84°34'58" W 106.08 FEET); THENCE ALONG THE ARC OF A 567.00 FOOT RADIUS CURVE TO THE RIGHT 96.44 FEET (CURVE HAS A CENTRAL ANGLE OF 09°44'42" AND A CHORD THAT BEARS S 85°48'16" W 96.32 FEET); THENCE N 89°19'23" W 58.37 FEET; THENCE N 00°37'38" E 1121.97 FEET; THENCE S 89°30'23" E 577.90 FEET; THENCE S 01°04'35" W 263.16 FEET; THENCE S 89°14'50" E 525.57 FEET; THENCE N 01°01'20" E 1343.57 FEET; THENCE EAST 33.76 FEET ALONG THE EXISTING AMERICAN FORK CITY BOUNDARY AS DEFINED BY THE DIXIE FENN ANNEXATION TO THE POINT OF BEGINNING.


BASIS OF BEARING: UTAH STATE PLANE COORDINATE SYSTEM, CENTRAL ZONE.
