RESOLUTION ANNEXING PROPERTY INTO HANNA WATER AND SEWER DISTRICT

November 7, 2018

RESOLUTION NO. 16

A RESOLUTION BY THE BOARD OF TRUSTEES OF THE HANNA WATER AND SEWER DISTRICT ANNEXING ADDITIONAL PROPERTY INTO THE BOUNDARIES AND SERVICE AREA OF THE HANNA WATER AND SEWER DISTRICT, AND RELATED MATTERS

WHEREAS, the Board of County Commissioners of Duchesne County, Utah has previously established the Hanna Water and Sewer District (the "**District**") and authorized the same to provide water and sewer services, together with all services and functions ancillary thereto and necessary and proper to carry out and provide the named services, to property lying within the boundaries set forth in those resolutions and authorizing documents previously approved by the Commission in the creation of the District, pursuant to the provisions of Article XI, Section 8 of the Utah Constitution and Section 17B-1-101, *et seq.* of the Utah Code (the "**Act**"); and

WHEREAS, the Board of Trustees of the Hanna Water and Sewer District (the "Board") desires to annex additional property into the boundaries and service area of the District;

WHEREAS, all of the property proposed to be annexed into the District will be benefited by said annexation, and the public health, convenience, and necessity require said annexation;

WHEREAS, notice of a public hearing was given and a public hearing was held regarding the proposed annexation on September 12, 2018;

WHEREAS, the Board met on October 10, 2018, to consider modifying the proposed annexation area pursuant to the Act and, by majority vote, modified the area proposed for annexation to exclude certain property to enhance the feasibility and reasonableness of the proposed annexation; and

WHEREAS, the time for any protests to be filed by interested persons has elapsed without an adequate number of protests being filed to forestall the proposed annexation or require an election under the Act, and any protests that have been filed or presented in person at the public hearing have been duly considered and taken into account by the Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Hanna Water and Sewer District as follows:

- 1. The public health, convenience, and necessity require the annexation of additional property into the boundaries and service area of the District.
- 2. The Board hereby approves the proposed annexation of property located in Duchesne County, Utah, as modified by the Board's actions on October 10, 2018. The property that is hereby annexed into the boundaries and service area of the District is more fully described in Exhibit A, attached hereto.
- 3. The Board directs its District Secretary to cause to be prepared and submitted to the Lieutenant Governor of the State of Utah the notice of impending boundary action in substantially the form attached hereto as <u>Exhibit B</u>, which notice shall be filed with a final, approved plat map within 30 days of this resolution.
- 4. The Board further directs its District Secretary to cause to be prepared the record of proceedings and certificate of compliance in substantially the form attached hereto as Exhibit C.1 and Exhibit C.2.
- 5. This resolution will take effect immediately upon its adoption.

ADOPTED, APPROVED, and ORDERED by majority vote at a duly called meeting of the Board of Trustees of the Hanna Water and Sewer District this November 7, 2018.
