ORDINANCE NO. 2018-11-07

"Amended North Hills Annexation"

AN ORDINANCE AMENDING ORDINANCE NO. 2018-08-22-1 ADOPTING THE NORTH HILLS ANNEXATION

WHEREAS, on the 22nd day of August, 2018, Manti City (the "City") adopted an ordinance referred to as the North Hills Annexation;

WHEREAS, the legal descriptions set forth in said original annexation ordinance contained a parcel of property that was inadvertently included in the annexation; and

WHEREAS, this ordinance is intended to amend and replace Ordinance No. 2018-08-22-1 to correct and remove said parcel; and

WHEREAS, all of the recitals and provisions of said Ordinance No. 2018-08-22-1 are incorporated by reference herein;

NOW, THEREFORE BE IT ORDAINED by the City Council of Manti City, Utah as follows:

<u>SECTION 1. Official Zoning Map Amended</u>. The Official Zoning Map of Manti City as adopted is hereby amended to include the annexed real property more particularly described below.

The real property, which is the subject of this Ordinance, is known as the *North Hills Annexation*, is located north and east of current Manti City boundaries shown on the records of Sanpete County, and more particularly described as follows:








VICINITY MAP
