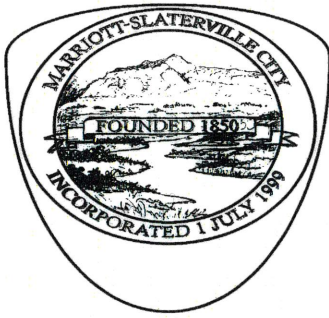

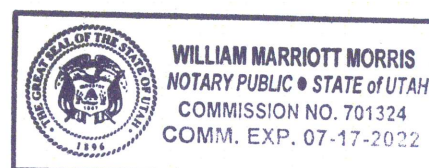

**A JOINT RESOLUTION OF MARRIOTT-SLATERVILLE CITY, UTAH,  
CHANGING THE NAME OF THE “MARRIOTT-SLATERVILLE CITY  
COMMUNITY DEVELOPMENT AND RENEWAL AGENCY” TO THE  
“MARRIOTT-SLATERVILLE CITY COMMUNITY REINVESTMENT  
AGENCY” AS PROVIDED IN UTAH CODE ANNOTATED §17C-1-201.5(3).**

**WHEREAS**, Marriott-Slaterville City (hereafter “City”) is a municipal corporation, duly organized and existing under the laws of the State of Utah;


**WHEREAS**, *Utah Code Annotated* §10-3-717 authorizes the City Council to “exercise all administrative powers by resolution”;

**WHEREAS**, the City previously adopted Ordinance 2015-02 creating the “Marriott-Slaterville City Community Development and Renewal Agency” under a prior state law;

**WHEREAS**, the Utah State Legislature has amended state law and the City desires to conform to state law by adopting this Resolution changing the name of the “Marriott-Slaterville City Community Development and Renewal Agency” to the “Marriott-Slaterville City Community Reinvestment Agency” as provided in Utah Code Annotated §17C-1-201.5(3).

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of Marriott-Slaterville City hereby change the name of the “Marriott-Slaterville City Community Development and Renewal Agency” to the “Marriott-Slaterville City Community Reinvestment Agency” in accordance with Utah Code Annotated §17C-1-201.5(3). The required Notice of Impending Name Change shall be directed to the Lieutenant Governor by the City as provided by law.
