On August 14, 2018, the Providence City Council adopted Ordinance 2018-008, an ordinance granting a petition for annexation and annexing the property described below, which is located adjacent to the north boundary of Providence City, in the general area of 400 East 500 North, Providence City, Cache County, Utah and legally described as follows:

PART OF THE SOUTHWEST QUARTER OF SECTION 2, TOWNSHIP 11 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN.

BEGINNING AT A POINT ON THE NORTH LINE OF 500 NORTH STREET (PROVIDENCE CITY) LOCATED North 75°50′56″ West, a distance of 3,713.87 feet from the southeast corner of said Section 2 and running thence North 01°44′17″ East, a distance of 791.25 feet; thence North 89°56′12″ East, a distance of 320.86 feet to the northwest corner of Providence Hollow Subdivision; then southerly along said west line the following six (6) courses:

- (1) South 00°21'55" East, a distance of 154.07 feet;
- (2) South 25°10'10" East, a distance of 80.21 feet;
- (3) South 31°25'52" East, a distance of 98.27 feet;

AN ORDINANCE GRANTING A PETITION FOR ANNEXATION FILED BY GREG GITTINS ON BEHALF OF SHIRLEY A. HENDERSON TRUST, ANNEXING PARCEL NO. 02-004-0012 LOCATED IN THE GENERAL AREA OF 400 EAST 500 NORTH CONTAINING 6.645 ACRES (+/-) and zoning the property Single-Family Traditional (SFT).

WHEREAS, Skarlet Bankhead, the duly appointed and acting City Recorder of Providence City, Cache County, Utah did hereby receive a Petition for Annexation and Plat which was filed with the City by Greg Gittins, on behalf of Shirley A. Henderson Trust; and

WHEREAS, the legal description for said property is as follows:

PART OF THE SOUTHWEST QUARTER OF SECTION 2, TOWNSHIP 11 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN.

BEGINNING AT A POINT ON THE NORTH LINE OF 500 NORTH STREET (PROVIDENCE CITY)

WHEREAS, the Petition was accepted by the Providence City Council for further consideration pursuant to UTAH CODE ANN. § 10-2-405 by Resolution 009-2018 adopted and passed by the City Council on March 27, 2018; and

WHEREAS, Skarlet Bankhead did certify, based on information received from Cache County and in consultation with the Providence City Attorney, that the Petition met the requirement of UTAH CODE ANN. Subsections 10-2-403(3), (4), and (5), and on June 22, 2018, did give Notice to the Providence City Council, the Contact Sponsor for said Petition, and Cache County of Certification; and

WHEREAS, pursuant to UTAH CODE ANN. § 10-2-406, Skarlet Bankhead did give Notice of Certification of Annexation Petition to each affected entity; and

WHEREAS, the Notice of Annexation was published in the Herald Journal on June 24, July 1, and 8, 2018; and

WHEREAS, no formal protests to the Petition have been received; and

WHEREAS the Providence City Council advertised and held a public hearing, in accordance with UTAH CODE ANN. § 10-2-407(3)(b), on August 14, 2018; and

WHEREAS, Providence City desires to provide for the health, safety, and welfare, and promote the prosperity, peace and good order, comfort, convenience, and aesthetics of each municipality and its present and future inhabitants and businesses, to protect the tax base, to secure economy in Ordinance No. 2018-008

governmental expenditures, to foster the state's agricultural and other industries, to protect both urban and nonurban development, to protect and ensure access to sunlight for solar energy devices, to provide fundamental fairness in land use regulation, and to protect property values in areas that may be considered sensitive, including but not limited to fire danger, slope, soil content, by following its Annexation Policy Plan and its General Plan; and

WHEREAS Providence City Code 10-3-6:A. states that new areas annexed into the City shall be annexed into the City as agricultural, unless otherwise approved by the City Council; and

WHEREAS, the Petitioner is requesting Single-Family Traditional (SFT) zone.

THEREFORE, BE IT ORDAINED that the Providence City Council:

- 1. Grants the Petition for Annexation filed by Greg Gittins, on behalf of Shirley A Henderson Trust; and
 - 2. The Providence City Corporate limits will be modified to include said property as described above; and
 - 3. The annexed parcel shall be zoned as Single-Family Traditional (SFT); and
 - 4. The Providence City Zoning Map shall also be changed to include the property as described and zoned above; and
 - 5. This Ordinance will become effective immediately upon passage and certification from the Lt. Governor's Office.




