RE: NOTICE OF IMPENDING BOUNDARY ACTION

Pursuant to and in accordance with the provisions of the "Utah Municipal Code," the City of Santaquin, Utah and Juab Counties, Utah, acting by its Mayor and approved by the City Council during a Public Meeting held on August 1, 2018, hereby requests amendment to its Articles of Incorporation as follows:

- 1. The name of the municipality is the Municipal Corporation of Santaquin, also known as the City of Santaquin.
- 2. The geographical description of the City is hereby amended to include the described property attached hereto as Exhibit "A" and known as the Summit Ridge Parkway Annexation "A"...
- 3. The City of Santaquin is a "City of the Fourth Class" as defined in Utah Code Ann. § 10-2-301(2)(d), having a population of more than 10,000 inhabitants, but less than 30,000 inhabitants.
- 4. These Amended Articles of Incorporation shall become effective on August 1, 2018.

ORDINANCE NO. 08-01-2018

AN ORDINANCE AMENDING THE ZONING MAP OF SANTAQUIN CITY TO INCLUDE THE SUMMIT RIDGE PARKWAY ANNEXATION "A" AREA LOCATED ADJACENT TO THE CURRENT CORPORATE BOUNDARIES OF SANTAQUIN CITY, UTAH

WHEREAS, on June 5, 2018, Santaquin City, who owns certain real property adjacent to the City of Santaquin (the "Petitioners"), petitioned to annex the real property described in Exhibit A (the "Property") to the City; and

WHEREAS, the Petitioners own the majority of the privately owned real property within the area proposed for annexation; and

WHEREAS, all Affected Entities have received notice of the proposed annexation; and

WHEREAS, on June 5, 2018, the Utah County Commission formally approved this annexation; and

WHEREAS, on August 1, 2018, the Santaquin City Council held a public hearing to receive public input concerning the proposed annexation, which public hearing was properly scheduled and noticed in accordance with Utah law; and

WHEREAS, the area proposed for annexation lies within the City's current Annexation Policy Plan; and

WHEREAS, Santaquin City, Utah desires to amend the Official Zone Map of Santaquin City to include the Property within the City's regulatory boundary.

NOW, THEREFORE BE IT ORDAINED by the City Council of Santaquin City, Utah as follows:

<u>SECTION 1. Official Zone Map Amended</u>. The Official Zone Map of Santaquin City as adopted by Section 10-7-2 of the Santaquin City Code is hereby amended to include the annexed real property as depicted in Exhibit B.

SECTION 2. Designation. The amended area shall be zoned Industrial (I-1) as depicted on the zoning map, a copy of which is attached hereto as Exhibit B and incorporated herein by reference.

<u>SECTION 3. Execution of Documents.</u> The Mayor is hereby authorized to execute AMENDED ARTICLES OF INCORPORATION OF THE CITY OF SANTAQUIN and a certification of the Santaquin City Council that the legal procedures for annexation have been completed.

<u>SECTION 4. Posting.</u> A copy of this ordinance shall be deposited in the office of the Santaquin City Recorder, and on August 1, 2018, the Santaquin City Recorder shall certify that this

Ordinance has been posted in three public places within the municipality, as provided in Utah Code Annotated § 10-3-711(1).

<u>SECTION 5. Effective Date.</u> This Ordinance shall take effect on August 1, 2018, and the described Annexation shall be effective upon the certification of the Utah Lt. Governor.


