Hyde Park City Ordinance 2019 – 11

An Ordinance Annexing 13.03 Acres pursuant to Section 10-2-407, U.A.C as Requested by Steven Taylor in behalf of Property Owners Geraldine Niederhauser and Kim Anderson

The City Council of Hyde Park, Utah, in a regular meeting, at which lawful notice was given, finds that in this particular instance, the City adopt an ordinance annexing 13.03 acres more or less of property, into the Hyde park City corporate limits.

Be if therefore ordained by the Hyde Park City Council that the 13.03 acres more or less of property described as follows:

A PART OF THE SOUTHEAST QUARTER OF SECTION 9 TOWNSHIP 12 NORTH, RANGE 1 EAST SLB&M
BEGINNING ON THE EXISTING CORPORATE LIMIT LINE AND FENCED NORTH RIGHT-OF-WAY LINE OF 3200 NORTH STREET
AT A POINT 1023.95 FEET S 89°41'10" W ALONG THE SECTION LINE (BASIS OF BEARING) AND 1478.70 FEET NORTH FROM
THE SOUTHEAST CORNER OF SECTION 9, TOWNSHIP 12 NORTH, RANGE 1 EAST SLB&M, AND RUNNING THENCE S
00°43'32" W 33.00 FEET TO THE CENTERLINE OF SAID 3200 NORTH STREET; THENCE N 89°16'28" W 639.55 FEET ALONG
SAID CENTERLINE; THENCE N 01°00'08" E 33 FEET TO A FOUND REBAR ON SAID FENCED NORTH RIGHT-OF-WAY LINE OF
3200 NORTH STREET; THENCE N 01°00'08" E 231.00 FEET ALONG FENCE TO FOUND REBAR AT THE SOUTHWEST CORNER
OF 4N HYDE PARK LLC PROPERTY; THENCE N 01°02'46" E 387.62 FEET ALONG FENCE LINE AND WEST BOUNDARY OF SAID
4N HYDE PARK LLC PROPERTY TO A FOUND SMITH REBAR & CAP; THENCE S 89°08'45" E 1032.14 FEET ALONG FENCE TO
THE EXISTING COPPPORATE LIMIT LINE; THENCE S 00°57'41" W 385.30 FEET ALONG SAID CORPORATE LIMIT LINE; THENCE
N 89°16'28" W 394.45 FEET ALONG SAID CORPORATE LIMIT LINE; THENCE S 00°43'32" W 231.00 FEET ALONG SAID
CORPORATE LIMIT LINE TO THE POINT OF BEGINNING. CONTAINING 13.03 ACRES MORE OR LESS.

Effective Date. This ordinance shall become effective upon passage by the City Council of Hyde Park City, Utah.
