ORDINANCE 18-15

WHEREAS the City of Smithfield has been asked to disconnect certain property from the existing Smithfield City limits and

WHEREAS the City of Smithfield has complied with the provisions contained in Title 10-2-501 and Title 10-2-502.5 of Utah Code Annotated and

WHEREAS such action now allows the City of Smithfield to proceed and comply with Title 10-2-507 of Utah Code Annotated.

NOW THEREFORE the City Council of Smithfield City, County of Cache, State of Utah, hereby adopts, passes and publishes the following:

AN ORDINANCE TO DISCONNECT CERTAIN DESCRIBED LAND FROM THE CORPORATE LIMITS OF SMITHFIELD, UTAH, COUNTY OF CACHE, STATE OF UTAH.

- 1. The real property, more particularly described in Paragraphs 2 & 3, below, is hereby disconnected from the City of Smithfield, County of Cache, State of Utah.
- 2. The real property which is the subject of this Ordinance is described as follows:

The Property is located at: 560 North 400 West, Smithfield, Utah.

Cache County Tax Parcel: 08-043-0009

A PART OF THE SOUTHEAST QUARTER OF SECTION 21, TOWNSHIP 13 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN.

BEGINNING AT A POINT WHICH LIES WEST 2330.64 FEET AND NORTH 658.03 FEET FROM THE SOUTHEAST CORNER OF SAID SECTION 21 (EAST 4.75 CHAINS AND NORTH 10 CHAINS AND NORTH ALONG THE EAST SIDE OF 400 WEST STREET AND WEST 0.25 CHAINS FROM THE SOUTHWEST CORNER OF SAID SOUTHEAST QUARTER BY RECORD), AND RUNNING THENCE EAST BY RECORD TO THE WEST RIGHT-OF-WAY LINE OF THE OREGON SHORT LINE RAILROAD; THENCE NORTHERLY ALONG SAID WEST RIGHT-OF-WAY LINE 6.93 CHAINS BY RECORD; THENCE WEST 8.37 CHAINS BY RECORD TO THE EAST LINE OF 400 WEST STREET; THENCE SOUTH 5.92 CHAINS BY RECORD; THENCE EAST 0.25 CHAINS BY RECORD TO THE SAID EAST LINE OF 400 WEST STREET; THENCE SOUTH BY RECORD ALONG SAID EAST LINE OF STREET TO THE POINT OF BEGINNING.

LESS THE PORTION LYING SOUTH OF A LINE DESCRIBED AS FOLLOWS: BEGINNING AT A POINT LOCATED WEST 2330.64 FEET AND NORTH 658.03 FEET FROM THE SOUTHEAST CORNER OF SAID SECTION 21 (EAST 4.75 CHAINS AND NORTH 10 CHAINS AND NORTH ALONG THE EAST SIDE OF 400 WEST STREET AND WEST 0.25 CHAINS FROM THE SOUTHWEST CORNER OF SAID SOUTHEAST QUARTER BY RECORD) AND RUNNING THENCE SOUTH 89°58'28" EAST, A DISTANCE OF 511.50 FEET TO THE WEST RIGHT-OF-WAY LINE OF SAID RAILROAD AND THE POINT OF ENDING.

FEET AND SOUTH 1°10'05" EAST 483.88 FEET AND SOUTH 89°51'57" WEST 5.95 FEET FROM THE WEST QUARTER CORNER OF SAID SECTION 21, AND RUNNING THENCE SOUTH 0°08'49" EAST, A DISTANCE OF 199.54 FEET ALONG SAID EAST RIGHT-OF-WAY LINE; THENCE SOUTH 85°33'57" WEST, A DISTANCE OF 549.42 FEET TO THE WEST RIGHT-OF-WAY LINE OF THE OREGON SHORT LINE RAILROAD; THENCE NORTH 8°00' 33" EAST, A DISTANCE OF 245.78 FEET; THENCE SOUTH 89°51'57" WEST, A DISTANCE OF 582.54 FEET TO THE POINT OF BEGINNING.

4. Per the provisions of Title 10-2-507 this disconnection will become official upon the State of Utah Lieutenant Governor's Office issuance of a Certificate of Disconnection.


